1) Opening

a. Call to Order

- The October 24th, 2018 meeting of the ASUNM Full Senate was called to order by Vice President Wilks at 6:00 p.m.

b. Roll Call

- All senators present except for Senator M. Lucas

c. Approval of Minutes

- MOTION was made to approve the minutes. The MOTION was seconded and passed unanimously.

d. Approval of Agenda

- Senator Ben: MOTION to add in "swearing of the Associate Justices". The MOTION was seconded and passed unanimously.
- Senator Ben: MOTION to add guest speaker Kim Kloeppel. The MOTION was seconded and passed unanimously.
- Senator Ben: MOTION to remove Appropriations 25F, 27F, and 28F. The MOTION was seconded and passed unanimously.
- MOTION was made to approve the agenda. The MOTION was seconded and passed unanimously.

2) Preliminary Business

a. Guest Speaker: SFRB Information

■ President Myers and Lucas Maestas: We are going to give you a rundown on SFRB. I can't give you specific details because we haven't finished voting on it. Our process for this year is for the fiscal year 2020. FTE stands for full time enrollment. The SFRB is comprised of students as we are using student fees. There are five students and two graduate students. There are three non-voting members as well. There are more undergraduate members because there are more than graduate students on campus. This is also because undergraduate students pay more student fees. The students on SFRB donate a lot of their time. We do unit tours to see where groups would use student fees. We avoid conflict of interest as well. There are three components to student fees: student government fees, building fees, and student activity fees. The SFRB only deals with the student activity fees. The role of the SFRB is to allocate the student activity fee to individual units, which includes departments. We provide recommendations and there is a vetting process for our recommendations. We make annual recommendations that has to do with any annual change to the fees. The Budget Leadership Team is an intermediary between the students and the president. They will vet our recommendations and decide whether or not to bring them to the president. The president will then decide whether or not to take our recommendations. We have had hearings all weekend so groups can explain to us why they need the student fees and how they would use them. We did three full days of hearings. The process of the hearing depends on how much money they request. We conducted student forums last week for student engagement. Students had an open mic and they would come talk about what services are important to them and why they need them. We have recessed until this coming weekend. We discuss how to fund and where to cut. As a representative, you must vote on everything. Recommendations are the final numbers we present to the president based on all of our deliberations. This year, President Myers is the chair and the GPSA is the vice chair. Based on last year, we allocated around \$15 million. This year we had \$17 million in requests and around \$13 million to allocate. We have a lot to deal with and we are really looking for student input.

- *Questions:*

- Senator Silva: Could you go more into depth on debt services?
 - a. Debt services is the facility fee for renovations, such as the Johnson Gym renovations. It goes towards specific projects each year, and the SFRB does not touch that.
- Senator S. Montoya: You mentioned how you want Senate to be involved during deliberations. What do you mean by that?
 - a. Reach out to your student organizations once we have our final numbers. We have time to get this feedback.
- Kim Kloeppel: I am the Chief Information Officer for Student Affairs. I have an initiative called “Be Kind”. I have been doing this for 16 years. We started this in SHAC and have been doing this ever since. This is basically an initiative to be kind, civil, respectful, and safe. This is an opportunity to pay it forward. The idea is that each day it is easy to be kind. It does not have to cost any money. It can be as simple as opening the door for someone or buying them a donut. With so many political problems these days, being kind is so important. If anyone is interested, we are putting together a Kind week. One of our biggest event is to collect stuffed animals for a children’s clothing bank and to the Albuquerque Police Department. Last year, we donated around 600 stuffed animals to them. We collect the stuffed animals at the Lobo Basketball games. UNMPD is also getting involved. We are looking to do this in February. “Fill it Forward” is where Satellite will give out coffee and donate the money to the Lobo Food Pantry. Each and everyday you can do something to be kind. It can be a simple thing. By being kind, it will actually reduce your blood pressure and have lots of other health benefits. We have a team of about 30 people across campus.
 - *Questions:*
 - Senator Silva: If we were to make the cards, would we just take them to your office?
 - a. Yes. If you need supplies we have that for you.

b. ASUNM President’s Report

- I wanted to give a shout out to ELL this year. Make sure to spend time with your mentee.
- Cherry Reel had all of their films submitted. That will be in December.
- November’s monthly initiative will be Athletics. Lobo Spirit is partnering with Lobo Basketball to take over the Pit.
- Housing Insecurity Initiative: We got donations for packs we made with Community Experience and made around 100 packs.

- SFRB: We are in deliberations now. On November 13th we will be presenting our recommendations. We have been working hard on conducting interviews for the student regent.
- Food Pantry Volunteering: We are working with Chartwells and UNM Food. We will need 12-15 volunteers. Please reach out to Chief of Staff Vernon if you are interested.

- f. Boards and Committees
- Senator Silva: Today was the SUB Board meeting. The Barbershop in the SUB was not paying their rent, so we are looking for a replacement. We want to replace it with another barbershop, a cell phone repair shop, or a graphic design shop for t-shirts.
 - Senator S. Montoya: I am sitting on the Student Publication Board. They had their first meeting recently. It was very preliminary. They elected a chair who will be running the meetings. - Senator Bennett: How many undergraduate and graduate members do you have?
 - a. We have no graduate members. We do serve about 20-35 undergraduate students.

3) Business

a. Finance Committee

- Vice Chair Kee: We had to fail three appropriations, but I am still proud of every committee member because they worked very hard.
- Appropriation 23F - American Institute of Aeronautics and Astronautics (AIAA)
 - Senator AlMidany: *Sponsorship Speech:* AIAA is wanting to go on a trip on November 7th to the Air Force base to look at their facilities. They are asking for money for gas mileage and rental fees. We reduced gas mileage because they did the math wrong. They requested money for advertisement. Rental fees was reduced because they were able to find a cheaper option.
 - *Questions:*
 - Senator Goranson: How many people will be going on this trip?
 - a. Senator AlMidany: About 20 students.
 - Senator Bennett: Are there any graduate students going?
 - a. Senator Morgan: No.
 - Senator Ben: How did you get \$96 for gas mileage?
 - a. Senator Kee: The trip is 220 miles round trip, and that is what we calculated it as.
 - Senator S. Montoya: Is the total gas mileage for one car? Is it in our standing rules to fund two cars?
 - a. Senator Roybal: They are taking two vans. Yes it is.
 - *Discussion:*

- Senator Ben: MOTION to increase line item 1 to \$176. The MOTION was seconded and passed unanimously.
- Senator Ben: I think this appropriation is great and the group seemed nice.
- Senator Rios: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- *Reopened Discussion:*
- Senator Morgan: We found notes saying that we funded them at \$96 because they are getting other funding.
- Senator AlMidany: MOTION to reduce line item 1 to \$96. The MOTION was seconded and passed unanimously.
- Senator AlMidany: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 18-0-0-2.
- Appropriation 24F - LoboSlam
 - Senator AlMidany: *Sponsorship Speech:* LoboSlam has a very small request for \$200 for honorarium for a guest artist that is coming and speaking to their organization.
 - *Questions:*
 - Senator Goranson: Are they going to charge non-UNM for the event?
 - a. Senator AlMidany: No.
 - Senator Rios: Who is performing and what are the dates?
 - a. Senator Ruja: It is the third Wednesday of every month and they are not sure who the guest will be.
 - Senator Bennett: How much is allowed in standing rules for honorarium?
 - a. Senator Morgan: \$100. We withdrew the standing rules because they were not asking for much.
 - *Discussion:*
 - Senator Rios: I am not sure how I feel about funding guest artists who are not confirmed yet. I know we fund what we know, and I don't feel comfortable funding something we don't know.
 - Senator Ben: LoboSlam is a slam poetry group on campus. Traditionally, the events that they are requesting money for do not go out and seek special guests, but for these events people

need to apply ahead of time. The reason that they do not know yet is because they choose the speaker the week of the event.

- Senator Morgan: They did have one name of a speaker.
- Senator Goranson: I feel comfortable funding them in full because it is a small request and they do have one artist already choSenator
- Senator S. Montoya: I do feel comfortable because this is the nature of the club. I think we should be supporting this.
- Senator Goranson: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.

■ Appropriation 26F - Taiwanese Student Association

- Senator Morgan: *Sponsorship Speech*: They are asking for money to take their students to Colorado. They want their students to see snow while they are in the U.S. We changed the travel per diem based on standing rules.
- *Questions*:
- Senator Goranson: How many undergrads will be attending?
 - a. Senator Morgan: I remember it being under 10.
- *Discussion*:
- Senator Goranson: I really like the nature of this trip.
- Senator Cary: I think this is a really wholesome appropriation. I understand what it is like to want to see something that you have never seen before.
- Senator Rios: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.

■ Appropriation 29F - UNM Geology & Environmental Science Club

- Senator AlMidany: *Sponsorship Speech*: This organization just came to speak to us. I will say that we have always supported them and they are a great student organization who shows a lot of spirit when they come to talk to us. They asked for money for upcoming trips, office supplies, food and refreshments, and honorarium.
- *Discussion*:
- Senator Goranson: I appreciate the fact that they came and spoke to us. I feel comfortable funding them in full.

- Senator Rios: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- Appropriation 30F - Women Student Veterans of UNM
 - Senator Roybal: *Sponsorship Speech*: This group came in and originally asked for \$7,338. Unfortunately, they are capped at \$500. We asked them what their priorities are and they listed lodging, travel, and airfare. We decided to put it all in travel so they can distribute it however they want.
 - *Questions*:
 - Senator Bennett: How many members do they have?
 - a. Senator Roybal: 50 undergrads and 10 grad students.
 - Senator Goranson: How many people are they planning on taking on this trip?
 - a. No answer.
 - *Discussion*:
 - Senator S. Montoya: I think we should fund this group in full. I encourage whoever their sponsoring senator is to reach out to them more.
 - Senator Goranson: I also feel comfortable funding them.
 - Senator Rios: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- Appropriation 31F - Nepali Student Association
 - Senator Morgan: *Sponsorship Speech*: They originally came to the last finance committee and their appropriation wasn't up to par, so they came back last week with more details. One thing we changed the line item for food to "supply cost" so we could give them more money. They ended up having to switch their caterer to American food based on the requirements for SUB catering.
 - *Questions*:
 - Senator Goranson: Why is facility rental the category for the banner?
 - a. Senator Roybal: It was not the right one but we changed it to "copying services" during committee.
 - Senator Bennett: Is this event open to anyone?
 - a. Senator Morgan: Yes.

- *Discussion:*
- Senator Roybal: I think we should fund this in full. When they came into committee, they redid their appropriation.
- Senator Goranson: I agree with previous senators and we should fund them in full.
- Senator Rios: MOTION to vote on the appropriation. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- Senator Kee left the meeting.

b. Steering and Rules Committee

- Senator Rios: We have a lot of business going through tonight. It was our longest meeting of the semester.
- Bill 5F - This defines the term “Classroom Components” in our definitions code
 - Senator S. Montoya: *Sponsorship Speech:* I put through this bill to add a definitions code. The definition that was submitted to S&R was worked on during a meeting a month ago. We slashed that definition and decided we wanted to change it more because it was too specific. We created this definition. We used to have extra credit. I think all of us are still open to putting in “requirement”.
 - *Questions:*
 - Senator Goranson: Why did you guys decide to cut out the extra credit component?
 - a. Senator S. Montoya: We decided that because it is covered in another section of the definition.
 - b. Senator Bennett: The purpose of striking that phrase was to make sure that this definition is open to enough interpretation. We are encompassing just a class credit hour and what is outlined in a syllabus.
 - *Discussion:*
 - Senator Cary: I like adding “required” because some classes do have extra credit in the syllabus. I think that if extra credit was in the syllabus, it does sound important.
 - Senator Ben: I would like discussion on moving “chartered” to after “student organization”.

- Senator Goranson: I also like the addition of “required” because most student organizations don’t have any choice in what professors put in syllabi.
- Senator Cary: MOTION to add the word “require” on line 29. The MOTION was seconded.
 - a. Senator Rios: Why?
 - i. Senator Cary: It is because some classes make extra credit not required, but important to the class. This definition would limit whether or not I could go.
 - b. Attorney General Hartshorn: I do not think it should be included. You have to remember that when funding an event, the intent is not going towards extra credit.
 - c. Senator Rios: As the Attorney General said, I don’t think this should be included.
 - d. Senator Goranson: I agree with previous senators.
 - i. A roll call vote was conducted and the motion failed with a vote of 0-19-0-1.
- Senator S. Montoya: I also think that it is an interesting idea of adding in the Student Activity Center, just to make it more specific.
- Attorney General Hartshorn: In the Lawbook, it does not mention the Student Activity Center.
- Senator Cary: We spent a long time doing this definition and worked really hard on it. To me, this definition is as perfect as it’s going to get. I think that because in the Lawbook it just says “chartered student organization”, we should leave it.
- Senator AlMidany: I commend the S&R committee on their hard work. I think we should pass it as is.
- Senator Rios: MOTION to vote on the bill. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the bill passed with a vote of 18-0-0-2.
- Resolution 6F - ASUNM recognizes the accomplishments of the UNM Beach Volleyball Team and does not support the Board of Regents decision to cut the team, or any other sport without sufficient consideration of input from the undergraduate student body
 - Senator Bennett: *Sponsorship Speech*: The purpose is to commend the Beach Volleyball team on their accomplishments. It goes on

to voice that ASUNM would like more involvement be extended to them with the Board of Regents.

- *Questions:*
- Senator Goranson: On line item 22, you write out the numbers but you don't on line item 23.
 - a. Senator Bennett: When we write out the numbers, it does not apply to scores.
 - b. Senator Cary: For this, the numbers represent what would be on a scoreboard. Writing out the numbers would be redundant.
 - c. Attorney General Hartshorn: It is all about the context. This is the formal way of writing it.

- *Discussion:*
- MOTION to vote on the resolution. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the resolution passed with a vote of 18-0-0-2.

- *Reopened Discussion:*
- Senator Silva: MOTION to move "President Garnett L. Stokes" after the student regent. The MOTION was seconded.
 - a. A friendly amendment was accepted to change "L" to "S".
 - b. The motion passed unanimously.

- Senator Cary: MOTION to strike "the" in line 71. The MOTION was seconded and passed unanimously.
- Senator Cary: MOTION to strike "the" in line 75. The MOTION was seconded and passed unanimously.

- MOTION to vote on the resolution. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the resolution passed with a vote of 18-0-0-2.

- Resolution 7F - ASUNM recognizes the accomplishments of the UNM Men's Soccer Team and does not support the Board of Regents decision to cut the team, or any other sport without sufficient consideration of input from the undergraduate student body

- Senator Bennett: *Sponsorship Speech:* This resolution highlights the accomplishments of the Men's soccer team and their accomplishments. It does demand the Board of Regents include the opinion of students with decisions going forward.
- *Discussion:*

- Senator Ben: MOTION to change the reference on line item 24 from 11 to 1. The MOTION was seconded and passed unanimously.
- Senator Silva: When we are sending the resolution to individuals, it is ordered in hierarchy. The Board of Regents should be above the President.
- Senator S. Montoya: Doesn't the President sit on the Board of Regents?
- Senator Rios: For line 28 and 30 we do not have (1st).
- Senator S. Montoya: MOTION on line 28 to add (1st). The MOTION was seconded and passed unanimously.
- Senator Goranson: MOTION on line 31 to add (2nd). The MOTION was seconded and passed unanimously.
- Senator Silva: MOTION to move "President Garnett L. Stokes" to after the regents. The MOTION was seconded.
 - a. Senator Callaghan: I want to point out that we did not do this on the last bill.
 - b. A roll call vote was conducted and the motion failed with a vote of 8-10-0-2.
- Senator S. Montoya: I think that we should move this over because it is a small change. I think there is a way for us to reopen the last resolution.
 - a. Attorney General Hartshorn: yes you can .
- Senator AlMidany: Whether we end up opening the past resolution, I would rather us have it correct on this resolution.
- Senator Cary: I think this is something we should do. It might look inconsistent now, but it is better to be right now.
- Senator Callaghan: Can this part of the bill be fixed out of senate?
 - a. Attorney general Hartshorn: No.
- Senator S. Montoya: MOTION to move "President Garnett L. Stokes" to after the student regent. The MOTION was seconded and passed unanimously.
- Senator Rios: MOTION to change the "L" to an "S" in "President Garnett L. Stokes". The MOTION was seconded and passed unanimously.
- Senator S. Montoya: A lot of the times we are saying ASUNM in the line items, but technically that applies that ASUNM is also speaking for the agencies. I don't know if we want to do that.

- Senator Assed: When President Myers signs it, it reflects all of ASUNM.
- Senator Bennett: MOTION to strike “the” on line 60. The MOTION was seconded.
 - a. Senator S. Montoya: I did not strike that because I think it would sound weird without it. We have “the” in front of other titles.
 - b. Senator Cary: If you delete “the” it makes more sense.
 - c. Senator Jaber: I think “the” should be there for the titles of athletics coaches.
 - i. A roll call vote was conducted and the motion passed with a vote of 10-7-0-3.
- Senator Gallegos: MOTION to add (1st). The MOTION was seconded and passed unanimously.
- Senator Rios: Do your homework beforehand.
- Senator Cary: MOTION to strike “the” on line item 63. The MOTION was seconded and passed unanimously.
- Senator Bennett: MOTION to vote on the resolution. The MOTION was seconded and passed unanimously.
 - a. A roll call vote was conducted and the resolution passed with a vote of 18-0-0-2.
- MOTION to reopen Resolution 6F. The MOTION was seconded and passed unanimously.
- Resolution 8F - ASUNM recognizes the accomplishments of the UNM Ski Team and does not support the Board of Regents decision to cut the team, or any other sport without sufficient consideration of input from the undergraduate student body
 - Senator Bennett: *Sponsorship Speech*: This commends the ski team on their accomplishments. It also serves to call upon the Board of Regents to sufficiently include more voices in decisions of this nature.
 - *Discussion*:
 - Senator Goranson: MOTION to add (2nd) to line item 28. The MOTION was seconded.
 - a. Senator Cary: We agreed not to do this in committee because this is a saying, not the literal term second.
 - b. A roll call vote was conducted and the motion failed with a vote of 1-16-0-3.

- Senator Bennett: I would like to point out that lines 32-34 on the first page and lines 9-11 on the second page read the exact same things.
- Senator Assed: MOTION to cut line items 50-52. The MOTION was seconded and passed unanimously.
- Senator Bennett: MOTION to insert “further” on line item 53. The MOTION was seconded and passed unanimously.
- Senator Goranson: MOTION to strike “the” on line item 21. The MOTION was seconded and passed unanimously.
- Senator Goranson: MOTION to move “President Garnett L. Stokes” after the student regent. The MOTION was seconded and passed unanimously.
 - a. A friendly amendment was accepted to change the “L” to an “S”.
- Senator Goranson: MOTION to strike “the” on line item 24. The MOTION was seconded and passed unanimously.
- Senator Bennett: MOTION to strike “the” on line item 65. The MOTION was seconded and passed unanimously.
- Senator Rios: For the footnotes, they are not in order.
- Senator Bennett: The clause that joint council was referring to was restated verbatim further down.
- Senator Rios: On line 35, before “crosses” should add “the Board of Regents”.
- Senator Assed: MOTION on line 2 to strike “Process of deciding”. The MOTION was seconded and passed unanimously.
- Senator Assed: MOTION to add “Board of Regents” on line item 2. The MOTION was seconded and passed unanimously.
- Senator Assed: MOTION to add “s’ decision” on line item 2. The MOTION was seconded and passed unanimously.
- Senator Rios: MOTION to cross out “was” and replace it with “were” on line item 1. The MOTION was seconded.
 - a. Senator Cary: We discussed this in committee, and it should be “was” because ASUNM is before the comma.
 - b. The motion failed unanimously.
- Senator Callaghan: On the last line in the section, I would rather shift the conversation from grammar to intention. I want to change it from “not involved” to “sufficiently included”.
- MOTION to vote on the resolution. The MOTION was seconded and passed unanimously.

- a. A roll call vote was conducted and the resolution passed with a vote of 18-0-0-2.
- Resolution 9F - ASUNM requests that undocumented and DACA students receive the same protections of the law
- Senator Rios: *Sponsorship Speech*: I met with the UNM Dream Team president and they wanted to write some resolutions about what their organization stands for. This resolution says that ASUNM requests that undocumented students receive the same protection under the law.
 - *Questions*:
 - Senator Goranson: Should we move the percent sign behind the number 74?
 - a. Senator Bennett: Yes we should.
 - Senator R. Montoya: Should there be citations for the studies?
 - a. Senator Rios: There should be, we failed to add them.

 - Senator Rios: I would like to see some discussion about keeping the sentence that contains 74% because it doesn't have a footnote.
 - Senator Silva: I think this resolution should be failed because I think there should be citations. I feel like it is not ready.
 - Senator Cary: I will also be failing it because I don't want it to seem like we are writing this without fact.
 - Senator Goranson: I think the most professional way to present this is with footnotes.
 - Senator S. Montoya: Something to take into consideration is that this resolution is meant to be passed with two other resolutions. We thought we would put through this one just to get the ball rolling. I wouldn't be against failing this one now so we can pass all three at once.
 - Senator Callaghan: I really like this resolution because it is good for students and I appreciate that this was written. I would rather talk about what the bills do for students and not about the grammar. I encourage you all to read over the resolutions before sending them in.
 - Senator Cary: It is not just that clause, but also lines 32-38 also do not have a source. The second clause on the second page also does not have a source. I do not think this is ready to be passed.
