1) Opening

a. Call to Order

- The September 26th, 2018 meeting of the ASUNM Full Senate was called to order by Vice President Wilks at 6:00 p.m.

b. Roll Call

- All Senators were present.

c. Approval of Minutes

- MOTION was made to approve the minutes. The MOTION was seconded and passed unanimously.

d. Approval of Agenda

- MOTION was made to approve the agenda. The MOTION was seconded.
- Senator Gallegos: Under Section 3 Business, I MOTION to change the "y" in "Liberty" with an "ie". The MOTION was seconded and passed unanimously.
- Senator Silva: MOTION to add Black Student Alliance to the speakers list. The MOTION was seconded and passed unanimously.
- Senator Rios: MOTION to Sec. 3 Sub Sec. C change "Government Affairs" to "Governmental Affairs". The MOTION was seconded and passed unanimously.

2) Preliminary Business

a. Guest Speaker: Lisa Lindquist – LoboRESPECT Advocacy Center

- Good evening everyone, I am Lisa Lindquist and I am the director for Lobo Advocacy Center. Many years ago, I was a senator and would like to thank you for your service. I wanted to share with you some things that we do. One of the things we do is we are the keepers of the mandatory sexual assault training. That includes two elements: the in-person Grey Area Training and we also do an online module called “Think About It”. You should have received an email invitation for it. The first thing that is important to know is that we are in agreement with the DOJ. We are about three years old, and what we do is provide a variety of support services for student. We are a confidential reporting center for sexual misconduct. If you have questions, are experiences, or know people who are experiencing it, we are a fact-finding location for you. You can give your name or not give your name. It can look like whatever a student comes in want it to look like. Through the lens of sexual misconduct, we can serve as an advocate for students facing sexual misconduct. If you are looking for support services, we can provide an advocate to help you. Regardless if you decide to report anything, if there is an area within the realm of Title 9, we are services for you. We understand all of the policies and processes and have the support to help students stay in school. We also help them if they decide not to stay in school. Faculty respects the fact that if we tell them not to talk to students, they will not. They are willing to work with us. We provide support in lots of areas. We are also “crisis intervention management”. We provide support for any type of crisis. Any level of intervention is what we are going to provide. Sometimes we are going to be a hand-holder. In addition to that, we also have a student group. If you are interested in furthering this movement, such as social movements around health and well-being, join PAWS. The one thing I was charged with asking you about is that we are interested in being more than mandatory education. We want to be more about being in front of social media. What are some topics you think would be good for students to hear about?
 - Senator Rios: I think hyper masculinity on a campus level.
 - Senator S. Montoya: I know domestic violence awareness month is coming up, so maybe hosting an event would be good for that.
 - We are aware of that and want to pair up to do something.
 - Senator AlMidany: Something I would like to see is a workshop on how to deal with situations where you are the friend of someone.
 - Senator Lucas: To all of the senators, I worked closely with LoboRESPECT this summer and they are so awesome. Tell everyone you know about them.

- LoboRESPECT: I am going to leave these cards here that have important numbers for support.

b. Guest Speaker: BSA

- Good evening everyone. BSA is an advisory board for Black students on campus. Wednesday, September 19, 2018 we released a statement about comments made by members of KKG at a new member summit. These comments were very offensive. I do not believe this was an isolated incident. It has made national news. We have met with lots of UNM faculty and campus leaders. In that we have highlighted some areas of campus climate that we believe is an issue. We did highlight Greek Life and ASUNM as a lack of representation. We identify that an unconscious bias training would be good with the Grey Area training. I would like to say that Greek Life as a whole should not be banned. We also talked about the disrespect about Dr. McIver. While people were respectful to UNMPD, they were not during Dr. McIver's presentation.
 - Senator Goranson: Thank you for coming in to talk to us. I know it can be hard to talk about this.
 - Senator R. Montoya: Thank you for coming in.
 - Senator Robinson: I want to thank you for coming, if you want to meet to talk about making ASUNM more diverse, please come talk to me.
 - Senator S. Montoya: Thank you for coming in.
- I think it would speak volumes if ASUNM wrote legislation about the BSA spoke out about an issue they thought was important. That would be important to us as an organization.

c. ASUNM President's Report

- Hi everyone. I have some information from our student service agencies. Thank you to everyone who helped at Fall Frenzy. Homecoming is this week. The preliminary results for the Homecoming court election will be shared in Friday at the pep rally. Silent Lights will be on Thursday in Smith Plaza. Please come. Lobo Spirit and SSE have worked hard.
- Our monthly initiative will be on Wellness. We are hoping to do partnerships with the SHAC and LoboRESPECT on wellness, stress, and anxiety. If this is something that interests you, please reach out.
- For Boards and Committees, please send any interested students to Dep. Chief of Staff Weiss. This is a great way to get involved in ASUNM.
- During Joint Council, we had a great conversation on resolutions and SFAE.
- Student Fee Review Board: Senator Assed was very helpful. We had 32 different groups come through and present. Forums will be held in the

atrium. All the small things matter, so it is important that your opinion gets heard.

- Enrollment: As you might know, there has been a dip in enrollment. This has greatly impacted campus. There is a proposed reduction for this current fiscal year. We have \$17.6 million in requests. Input will really help us.
- Student Regent applications have been released. If you know anyone interested, please tell them to apply. They cannot be a university employee. We are trying to get a diverse applicant pool. We also want to partner with GPSA on this. Applications are due October 8th.
 - Senator Salazar: When is the student fee forum?
 - Monday, October 15th and Wednesday, October 17th.

d. ASUNM Vice President Opening Remarks

e. ASUNM Executive Agencies

- **Arts and Crafts Studio**
 - Senator Goranson: The Arts and Crafts Fair will be in the end of November. The vendors will need help setting up.
- **Community Experience**
 - Senator R. Montoya: They just had Fall Frenzy and over 200 people attended. They will be going to Roadrunner Foodbank and hosting a blood drive.
- **Elections Commission**
 - Senator Rios: Today was homecoming elections. For online voting, people could vote more than once, but IT was contacted and the issue was fixed. The last vote you submitted will be the one counted for. Senatorial elections are coming out on October 8th.
- **Emerging Lobo Leaders**

f. Joint Council

- We just started with discussing the last full Senate meeting. Council members had questions about BSA, student regents, and FSAE.

- Senator Assed: We really want you guys along with student orgs to come out to the student forum.
- Senator Silva: Today we had our second SUB Board meeting. Pi the pizza place is open on the second floor. The Draft and Table is open today. There was a lot of great input on the new Smith Plaza, especially from ARC.

h. Public Comment

- My name is Charlene Blackridge and I represent ARC on Joint Council. I want to go over the resolution about ADA compliance. Last spring was when the resolution was first introduced. A lot of people from ARC got together and talked about accessibility on campus. We are required to have an ADA plan by law, but UNM has a really old plan. There were some issues with Anderson. ADA is not in the forefront of people's minds right now which is not good. We not only need to be ADA compliant but also accessible. This resolution is essentially covering all of that.
- We are from Beta Alpha Psi. We are a business honor society specifically for management information systems, finance, and accounting. We have three meetings this semester to network with professionals. We want to help our students get jobs. Through your help and funding, we want to go to conferences. We thank you for all that you do.
- Senator Lucas: I have a message from LoboCatholic- "Thank you all for your time and consideration. I hope the senate will take the Finance consideration. I would like to address the source of our funding. The funds we receive from outside sources are seen by the Newman Center. LoboCatholic does not see any of these funds. We are asking ASUNM to help fund our student group for the facility. We are estimating about 100 students to go to this retreat."
- Ryan Lindquist: The taproom will actually open on Monday.

3) Business

a. Finance Committee

- Senator Lucas: Our finance committee has completed the deliberation process for this semester. Those who are sponsoring senators for the budgets who went through, you are going to send out emails about why some reductions were made. Additionally, we do not have a general fund number for this week. Thank you all for asking questions about appropriations.
- Appropriation 8F – Beta Alpha Psi
 - Questions:
 - Senator Morgan: Sponsor speech: They came and asked for money for conferences. We approved most of the items. We had to reduce some items due to standing rules. There should be a change to line item 4.
 - Senator S. Montoya: What number should line item 4 read?

- A roll call vote was conducted and Appropriation 9F passed with a vote of 20-0-0 at \$3,603.
- Appropriation 10F – Society of Women Engineers
 - Senator Roybal: Sponsorship speech: They are asking for additional funding for their trip to the SWE annual conference, a commuter, and food and refreshment. Their membership has tripled and the conference is a very valuable experience.
 - *Questions:*
 - Senator Rios: Do they have an office to store the computer?
 - Senator Roybal: Yes.
 - Senator Goranson: Are there graduate students?
 - Senator Roybal: There are 4 grad students and 60 undergrads.
 - *Discussion:*
 - Senator Roybal: I think we should fund this in full.
 - Senator S. Montoya: I am their sponsoring senator. They are a pretty awesome organization. I think we should fund in full.
 - Senator Bennet: I used to be a member of this organization. I think we should fund this and send them to this amazing conference.
 - Senator Rios: MOTION to vote on Appropriation 10F. The MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and Appropriation 10F passed with a vote of 20-0-0 at \$1,887.
- Appropriation 11F – Society of Physics Students
- Senator AlMidany: Sponsorship Speech: This student org has 30 undergrads and 0 grad students. They are requesting money to attend a conference in Salt Lake City. You can see a lot of cuts, but that is because of the math and calculations for each line item. Their last line item was cut due to standing rules.
- *Questions:*
- Senator R. Montoya: Do they fundraise?
 - Senator Kee: They do get some funding from the physics department however they do not do fundraising and are looking into doing some more.
- Senator Goranson: Under purpose of funding, it says they requested conference money and will use the extra for other things. Do they actually need this money?
 - Senator AlMidany: I am not sure that I understand your question, but the \$5,000 they requested we cannot fund anyways. In their original request, they said the physics department will help them fund for this trip.
- Senator Rios: How many students go to the conference?

- Senator AlMidany: I believe 24.
- *Discussion:*
- Senator Roybal: I want to encourage their sponsoring senator to help them fill out their appropriation so they can get the most money they can get.
- Vice President Wilks MOTIONED to vote on Appropriation 11F.
 - A roll call vote was conducted and Appropriation 11 F passed with a vote of 20-0-0 at \$1,036.
- Appropriation 12F – UNM Women’s Ultimate Frisbee
 - Senator Gallegos: Sponsorship Speech: They are requesting money for two tournaments they are going to. The honorarium line item is for their volunteer coach. The other supply costs are for their jerseys which they are required to wear. They will reuse them and found a sale on them.
 - Questions:
 - Senator S. Montoya: When was the last time they requested money for jerseys?
 - Senator Kee: Never.
 - Senator Bennet: How many members? How much does it cost per jersey?
 - Senator Gallegos: They have over 30 members. It costs \$95.
 - Senator Goranson: Is this the first year they are attending these tournaments?
 - Senator Kee: This is the first year they have enough members to.
 - *Discussion:*
 - Senator Morgan: This group was really energetic. If you want, they are selling jerseys if you want to buy one.
 - Senator S. Montoya: I am their sponsoring senator. They are really passionate. They have fundraisers and their team has doubled in size. I think we should support them. They can bring a lot of great recognition to campus.
 - Senator Kee: I want to reiterate what everyone is saying. They are having a Chipotle fundraiser.
 - Senator Roybal: MOTION to vote on Appropriation 12F. The MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and Appropriation 12F passed with a vote of 20-0-0 at \$5,759.

b. Steering and Rules Committee

- Senator Rios: At this past committee, we went over 4 resolutions and only 3 will be heard tonight. Just so everyone knows, we don’t just pass everything. We don’t just look at grammar.

- Resolution 1F – Encourages UNM to be more ADA compliant
 - Senator R. Montoya: Sponsorship Speech: This resolution is meant to display ASUNM’s support of a more accessible campus. We shouldn’t just be meeting ADA requirements, we should be exceeding them. Going to ARC’s meetings made me want to be a senator.
 - *Questions:*
 - Senator Goranson: Where did the information about UNM’s transition plan being obsolete come from?
 - Senator R. Montoya: This student group has gotten their information from agencies.
 - Senator AlMidany: Would the author of this piece elaborate more about who will be receiving this and why?
 - Senator R. Montoya: These are all administrators that can oversee accessibility issues and physically implement it.
 - Discussion:
 - Senator Ben: MOTION on page 2, line item 8 change “oppertunity” to “opportunity”. The MOTION was seconded and passed unanimously.
 - Page 1, line item 35
 - Senator Gallegos: MOTION to capitalize “transition plan” on line item 35. The MOTION was seconded and passed unanimously.
 - Senator Gallegos: MOTION on page 2, line item 6, change it to read “Nasha Torres”. The MOTION was seconded and passed unanimously.
 - Senator Lucas: I want to thank the authors of this resolution to put through this resolution. As a New Student Orientation leader, I worked with students with disabilities and you don’t realize the things they go through every day to get from place to place.
 - Senator Goranson: I also really like this resolution. I think we should add the candidates for governor because they appoint Board of Regents members.
 - Senator S. Montoya: MOTION on line 8 to delete the period and add “Representative Ben Ray Lujan and Representative Michelle Lujan Grisham”. The MOTION was seconded and passed unanimously.
 - Senator Rios: Friendly amendment to cross off before “Office of Equal Opportunity”.
 - The author accepts.
 - Senator Robinson: Did we mean to put the gubernatorial candidates? Because Rep. Ben Ray Lujan is not one.
 - Senator Cary: Friendly amendment to strike “Rep. Ben Ray Lujan” and add “Representative Steve Pearce”.
 - The author accepts.

- The MOTION passes unanimously.
 - A roll call vote was conducted and Resolution 2F was passed with a vote of 20-0-0.
- Resolution 3F – Encourages students to participate in the upcoming November elections
 - Senator Silva: Sponsorship Speech: This resolution states that all of the offices up for election this November and encourages students to register to vote and to vote. This resolution also has where they can vote and a link to register to vote.
 - *Discussion:*
 - Senator Gallegos: MOTION to add “s” after “African American Student Service”. The MOTION was seconded and passed unanimously.
 - Senator Gallegos: MOTION to change page 1, line item 35 to read “ensure”. The MOTION was seconded and passed unanimously.
 - Senator R. Montoya: MOTION to put a period on line item 20 after “state-wide offices” and change “including” to “include”. The MOTION was seconded.
 - Senator Bennet: We usually try to keep each clause as one sentence.
 - Senator Rios: We try to keep each clause as one sentence just so it is easier to read.
 - Senator Cary: As far as I know, there is no rule that says each clause has to be one sentence, but in this case, I think it is whatever you as senators think make the most sense.
 - A roll call vote was conducted and the MOTION passed with a vote of 11-9-0.
 - Senator S. Montoya: The reason why we don’t put periods is because it is not a complete sentence. I think if we change this, then we would have to make a new clause for it for consistency.
 - Senator Assed: MOTION to move the sentence beginning with “Whereas” to a new clause. The MOTION was seconded. The MOTION was seconded and passed unanimously.
 - Senator Bennett: Lines 31-33 are in a different font.
 - Senator R. Montoya: Point of clarification, I have several changes, do we have to vote on all of them at once?
 - AG Hartshorn: If they are all different, then
 - Senator R. Montoya: MOTION on line item 23 to change it to read “State Land Commissioner”. The MOTION was seconded and passed unanimously.
 - Senator Robinson: Do we need to state “New Mexico” land commissioner?
 - Senator R. Montoya: We haven’t specified New Mexico on other ones.

- Senator R. Montoya: MOTION on line item 28 to add “early vote beginning on Saturday October 20th, 2018 through Saturday, November 3rd, 2018, Monday through Saturday from 8 A.M. to 8 P.M. and on election day,” The MOTION was seconded.
 - Senator Lucas: Friendly amendment to change “early vote” to vote early”
 - Senator R. Montoya accepts.
 - Senator Gallegos: Friendly amendment to capitalize “election day”.
 - Senator R. Montoya accepts.
 - Senator Cary: Friendly amendment not to include “th” or “rd” after the days.
 - Senator R. Montoya accepts.
 - Senator Robinson: Friendly amendment to add “Tuesday” before “November 6th, 2018”.
 - Senator R. Montoya accepts.
 - Senator Silva: Friendly amendment to cross out “vote on”.
 - Senator R. Montoya accepts.
 - Senator Lucas: Friendly amendment to place a comma between “2018” and “Monday”.
 - Senator R. Montoya accepts.
 - The MOTION passes unanimously.
- Senator R. Montoya: MOTION to change “voice” to “voices” on line item 38. The MOTION was seconded and passed unanimously.
- Senator R. Montoya: MOTION to change line item 39 “is” to “are”. The MOTION was seconded and passed unanimously.
- Senator Cary: MOTION to add a comma after “center” on line item 7. The MOTION was seconded and passed unanimously.
- Senator Cary: The State Land Commissioner I believe is actually called the “New Mexico Commissioner of Public Lands”.
- Senator Roybal: I agree with Senator Cary.
- Senator Cary: MOTION to change line item 23 to read “New Mexico Commissioner of Public Lands.” The MOTION was seconded and passed unanimously.
 - Senator Silva: So it says “New Mexico” at the beginning of the clause, already stating that every office is already part of the state of New Mexico.
 - Senator Bennett: Friendly amendment to strike “New Mexico”.
 - Senator Cary accepts.
 - A roll call vote was conducted and the MOTION passed with a vote of 20-0-0.

- Senator Cary: I am sure that the title of this position is “Public Lands”.
- Senator Roybal: If you look it up, it says “Public Lands”.
- A roll call vote was conducted and Resolution 3F passes with a vote of 20-0-0.
- Resolution 4F – Encourages students to vote on General Obligation bonds during the November elections
 - Senator Silva: Sponsorship Speech: This resolution encourages us to vote on this bond which is the primary source of funding for New Mexico higher education. It would go towards renovating the chemistry building and building a new ROTC building.
 - Questions:
 - Senator S. Montoya: Would adding the name of the chemistry building be important?
 - Senator Silva: It would be nice, but I could not find the name.
 - Discussion:
 - Senator Robinson: MOTION to place “Tuesday” before “November 6th, 2018”. The MOTION was seconded.
 - Senator Rios: Does there have to be a comma after “Tuesday”?
 - Senator Rios: Friendly amendment to add a comma after “Tuesday”.
 - Senator Robinson accepts.
 - The MOTION passes unanimously.
 - Senator Bennett: Just so you know, this is just encouraging students to vote.
 - Senator Goranson: MOTION to cross out “th” on line item 9. The MOTION was seconded and passed unanimously.
 - Senator Gallegos: MOTION on page 2, line item 3 to add an apostrophe to “programs”. The MOTION was seconded and passed unanimously.
 - Senator Goranson: MOTION to add a comma after “team building”. The MOTION was seconded.
 - A roll call vote was conducted and the MOTION failed unanimously.
 - Senator Lucas: If senators are still interested, I found the name of the chemistry building is Clark Hall.
 - Senator Goranson: MOTION on page 1, line item 25 to add “Clark Hall” after “chemistry building”. The MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and Resolution 4F passed with a vote of 20-0-0.

c. Outreach and Appointments Committee

- Senator Silva: We had 15 appointees come in and we passed 14 of them.
- Xavier Vallejos, Executive Director, Student Special Events
 - Senator Jaber: We interviewed Xavi for the executive director of SSE. He was very enthusiastic and wants to make Fiestas a bigger event. He has some interesting financial strategies he wants to bring to SSE.
 - Senator Gallegos: Can you expand on the financial strategies?
 - Senator Jaber: He wants to organize the budget, focusing on bigger events and cutting off less valuable events.
 - Senator Goranson: He also wants to make SSE more sustainable, like looking for more sponsors.
 - Senator Lucas: I know Xavi is really passionate and enthusiastic. I highly recommend voting for him.
 - Senator Goranson: I think he is a great appointee. He came in with great ideas and is very excited.
 - Senator AlMidany: I have known Xavi for a year now and I am very impressed with him. I think he would be a great executive director.
 - Senator Robinson: He is a great candidate. He has put together a great team of people.
 - Senator Silva: I work in the SAC and Xavi is constantly meeting with our advisors which shows how passionate he is. He is pushing graphics for his events so more people will come.
 - Senator Rios: I was in the same ELL class as Xavi and I can see how much he has grown within ASUNM.
 - A roll call vote was conducted and Xavier Vallejos was approved as the Executive Director of Student Special Events with a vote of 20-0-0.
- Tori Martinez-Varela, Executive Director, Southwest Film Center
 - Senator Goranson: Tori is very passionate about what she does. She has great experience within Southwest Film Center. She also has really great goals. She is looking into sponsorships for the Cherry Reel Festival.
 - Senator Silva: Tori came into her interview with marketing ideas. She is very passionate about the Cherry Reel Festival. She got Cannon to sponsor the festival.
 - Senator Robinson: Based off of her past experience, she has already done a great job.
 - A roll call vote was conducted and Tori Martinez-Varela was approved as the Executive Director of Southwest Film Center with a vote of 19-0-1.

- Senator Ben: MOTION to block vote on all paper applications. The MOTION was seconded and passed unanimously.
 - Senator Silva: O&A passed all of these candidates and feel very confident in all of them.
- Lacy Garner, Assistant Director, Emerging Lobo Leaders
 - Senator Salazar: Lacy is charismatic and responsible. In her application, she has shown that she can build relationships with every member involved. We thought that she was the best appointee.
- Libertie Green, Assistant Director, Government Affairs
 - Senator Silva: Libertie's resume states that she was a campaign intern which I think is an asset to this job, especially with putting on events.
- Genevieve Romero, Project Director, Government Affairs
 - Senator R. Montoya: Genevieve is extremely knowledgeable in governmental affairs. Even in high school, she was involved in Girl's Nation. I know they go through a lot of training for lobbying for Girl's Nation. I think she is very well versed in what this job entails.
- Todd Moe, Assistant Director, Southwest Film Center
 - Senator Robinson: The appointee has leadership experience both in high school and as a NSO leader, making him a very strong applicant. I think he will help in the executive director's mission.
- Amadeo Hughes, Marketing Director, Southwest Film Center
 - Senator Jaber: He has readiness and is dedicated to this position. He has past experience as an RA. He founded and directed his own clothing company.
