



ASUNM FULL SENATE MINUTES

02-06-2019

1) Opening

a. Call to Order

- Vice President Wilks called the February 2, 2019 meeting of the full Senate to order at 6:00 pm.

b. Roll Call

- Senator Morgan was absent and Senator Gonzalez was late.

c. Approval of Minutes

- MOTION was made to approve the minutes. MOTION was seconded and passed unanimously.

d. Approval of Agenda

- MOTION was made to approve the agenda. MOTION was seconded.
 - Senator Gallegos: MOTION to add "Mark Peceny and Philip Ganderton for Differential Tuition" to guest speakers. MOTION was seconded and passed unanimously.
 - The agenda passed unanimously.

e. Open Meetings Act Resolution

- MOTION to approve the Open Meetings Act Resolution. MOTION was seconded and passed unanimously.

2) Preliminary Business

a. Guest Speakers- Mark Peceny and Philip Ganderton:

- The college of Arts and Sciences is the largest school in campus. We deliver about 60% or more of the credit hours on campus. AS the largest college, we have often been underfunded. We struggle to maintain the excellence we want to deliver to every student. We have come with a request for differential tuition. Part of the reason we are doing this is because we have lost faculty and staff. We are trying to restore some of these things. We are also bringing this forward because we think it is a better model for the university to use. The current funds are distributed incrementally. If you approve differential tuition, it goes directly to the colleges that deliver instruction. A large portion of this goes into staff stipends in both undergrad and graduate programs. Four years ago, we spent more on staff than we do on stipend positions. Now, it is not the same. We have lost \$1 million of staff and are spending about \$2 billion

less on staff. Differential tuition will help us restore these investments. We lose a lot of our advisors as well. If this is improved, we can raise salaries for these advisors. The purpose of this is to create a model for budgeting for the university. This is the second year we have submit this request. This year it looks like it might pass. Each major in the college will be charged \$10. Approximately only 60% of your tuition goes into academics. All of this money would go straight into the college of Arts and Sciences. We pledged not to spend any of this tuition on staff. We will keep this in a different account and publish a statement every year. We want to create a student advisory board which will make recommendations on how to spend money for the next year. We have already had some success with summer grants that allow students to take courses over the summer. There would be nothing spent on operating costs or overhead. We have also submitted a separate request for graduate education.

- Senator Silva: I think what you are doing is great, and I know you have had a lot of student input. I want to thank you for always wanting to have student input on this. I think this is money is really necessary.
- Senator Goranson: Thank you for coming to talk to us. How would the student advisory board be selected?
 - We haven't really thought of this yet. Other school that have done this are doing it for schools that are much smaller. We would spend time over the next semester finding all of these details. I anticipate that we would be happy to come back to this body to discuss this every year.
- Senator Lucas: Thank you for coming to talk to us. I went to the Joint Council meeting where you have presented this last year. What has changed since then?
 - Nothing has changed. We are anticipating more openness in the leadership in the university. These traditional incremental models tend to build in historical patterns of behaviors and isolated faculty from the students.
- Senator Assed: Thank you for coming. I think it is admirable that you want to make these changes. With the \$10 amount, do you ever see that increasing over time?
 - I could anticipate that it would change over time, however, this would help us increase enrollment instead of increasing tuition. I think it could increase as long as we also increase general attractiveness to students.
- Senator Roybal: Thank you for coming. Are you doing anything else to get student input on the \$10 increase?
 - Last year, we did a survey with about 500 responses. We went to meetings of student groups in every department. In fact, after doing this, we adjusted the amount we are

requesting from students. \$10 has some basis, but there could be some consideration about it being lowered.

- Senator Woodworth: I think this is really interesting. From my understanding, you will be receiving more money from the “pot”. Will we see deficits from other departments?
 - No, it wouldn’t take away from other departments. The \$10 differential tuition will go directly to the students. We want to give students the best value education at UNM.
- Senator Varela: Thank you for coming tonight. Doesn’t this actually discourage students?
 - We expect anyone who is close to graduating will be willing to pay slightly more to finish their education. Once you get to the upper division, you are more likely to have smaller classes and more experienced professors, which is a higher value experience.

b. ASUNM President’s Report

- 2019 Legislative Session- A few of the bills we talked about last time are in a limbo stage where we don’t know exactly where they are going. One of these bills is the one about unclaimed prize money. We are continuing to push this. SB 283 is a 15% administrative cap on any money that is not paid out or used for awards. Right now the cap is about 20%.
- Agency updates- Last night ELL had their meet and greet, but there was not a lot of people there. Next week, I invite you all to come and meet the ELL-ers before their meeting. It is open so you do not have to tell me if you are coming. Michael Sam is coming soon to speak. I would like to see you all there. This is one event I am most excited about.
- Presidential Election packets- Packets will be out 2/13. No election talk in the office. Vice President Wilks and I are hoping to do an event to talk about what this was like for us.
- Special shoutouts- The Howl has been a tremendous success. Thank you to the senators who have been coming to the games. Please keep going to the games! Governmental Affairs did an amazing job at UNM Day. This was a very transitional time for them, but they did a great job. Everyone who came did a tremendous job.
- University Budget Process- The budget summit is April 5th. What Arts and Sciences just spoke about is part of a larger conversation we are having during this process. Budget hearings are coming up, and I want to encourage you guys to come. It makes you well-informed.

i. Senator Accountability

- Senator Woodworth received a demerit for failing to reach out to her student organizations. She does not receive any punishments.

d. ASUNM Executive Agencies

- i. Arts and Crafts Studio
 - Senator Gonzalez: They are going to have more dates coming to use for fairs that are happening later in the semester.
- ii. Community Experience
 - Senator Goranson: This Saturday, they are going to the Barrett House from 10-12. They are also tabling at the Be Kind fair. They are looking for volunteers for a basketball game.
- iii. Elections Commission
 - Senator Jaffe: 2/13 packets will be out for Presidential elections. 3/5 is the candidate meeting, 3/18 is the endorsement forum, and the election period beings 3/25.
- iv. Emerging Lobo Leaders
 - Senator Gallegos: They had their first meeting yesterday and they have 25 students. They need senators next week for the executive office rotations.
- v. Governmental Affairs
 - Senator Roybal: UNM Day went well and they are working on Capital Outlay now.

 - Senator Silva: Last night was the SDSU game. They went to the dorms last night and urged students to go to the game. They are working with UCAM on Lobo Day. For Lobo Day the theme is going to be “throwback”.

 - Senator Romero: They are bringing the Mountain Film Festival to the theater this weekend. They are partnering with the UNM Wilderness Alliance.
- e. Joint Council
 - There were a lot of senators at Joint Council this week so that was great. AISS is hiring for their summer bridge program. They need an RA and English and Math tutors. The College of Engineering is having a panel. The College of Fine arts is hosting a goth prom on 2/15. The Department of Mathematics is having a lot of workshops. GEO is having a study abroad fair next week. For Bill 2S, the discussion was about the specifics of how it would change things. For finance, there wasn't any problems. If you want to be added to the Joint Council email list, let me know.
 - Senator Montoya: With Bill 2S, how did they feel about the changes?
 - They wondered if any changes would be reviewed by anyone else besides the Attorney General.
- f. Boards and Committees

- Senator Gonzalez: I attended a meeting for the Seal committee. We are in the process of looking for local artists who would submit something for a new seal. The seal goes on important documents. The seal we have been using did not represent the university well or higher learning. You can email me if you know anyone who would be interested in creating a seal. The call to artists will come out in May.

g. Public Comment

- Men's Rugby: I want to express our appreciation for all you have done in the past. By giving to us, we also give to the community. We have gone to Joy Junction and helped there.
- Kappa Kappa Psi: We appreciate all of the help you have given us. With our appropriation, we grouped two of our conventions. Is there anything we could clarify?
 - Vice President Wilks: I believe our Finance Chair has information for the senators and will help fix them. The mistake was they had two travel per diems to the same location, but there will be increases made when we get to your appropriation.
- Something Major Acapella: We are requesting money for a venue and for professional services. I have a quote now for the venue because I was able to meet with someone this weekend. We requested \$250, but the quote is for \$1,000. We came here to ask if you all would raise our rental fees to \$600 and take our the professional services request, because professional services would be included in the rental fees. Thank you for providing these funds for us. As we are a musical performance group, it is hard for us to raise money or get paid.
 - Senator Goranson: How many are you expecting in attendance at the event?
 - We are hoping to have students, faculty, and friends.
 - Senator Montoya: Are you still going to charge entrance fees?
 - Yes we are.
 - Senator Lucas: I am your sponsoring senator, so if you need anything let me know!
- Lobo Hockey: Thank you for giving up your time to be here. The funds we are requesting are going to good things. They will go towards facility rentals and outreach. We do a lot of outreach with little kids as well.

3) Business

a. Finance Committee

- Senator Gallegos: With conference fees, we will be adjusting them in our next meeting. We are still following the 50% reduction, but our standing rules do not necessarily stand in full Senate. But since we have funded other organizations this way so far, we should do the same with these until we change the standing rules. The new standing rule will say

something to the effect of “we will fund up to \$250 or 50% on fees of \$500 or more.” Budget requests were due to me today, and we are hearing 93 budgets. We would love to see you all there. Those will be the last two weekends of February and the first weekend in March.

i. Appropriation 5S - SCRAP Productions

- *Sponsorship Speech:* Senator AlMidany: They are a production organization putting on their semesterly production of “The Bachelorette”. The money will go towards supplies to build the set, props, and costumes. The committee felt comfortable funding them in full.

ii. Appropriation 7S - Health Occupation Students of America (HOSA)

- *Sponsorship Speech:* Senator Gonzalez: They are requesting money for a leadership conference. They are wanting to take 14 members. This is the first conference they are attending.

- *Discussion:*
- Senator AlMidany: MOTION to increase line item 1 to \$500. MOTION was seconded and passed unanimously.
- MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.

iii. Appropriation 8S - Student Organization for Latin American Studies (SOLAS)

- *Sponsorship Speech:* Senator Romero: They are having their annual Sin Fronteras Film Festival at the Guild. There are going to be 5 films, and it is open to the public. They have also received money from GPSA. They are requesting \$500 to rent one film.
- *Questions:*
- Senator Goranson: Are they a new student organization?
 - Senator Gallegos: They are capped at \$500.
- Senator Montoya: Will they be charging admission?
 - Senator AlMidany: It is a free event.
- *Discussion:*
- Senator Goranson: I feel comfortable funding this in full.

- MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- iv. Appropriation 9S - Association for Sustainability and Corporate Social Responsibility
 - *Sponsorship Speech:* Senator Roybal: This group is asking for money for an event they are going to be having which is a workshop on sustainability. They requested money for a computer, and they do have an office to store it on campus. They are creating an app to track your carbon footprint.
 - *Questions:*
 - Senator Groanson: What is included under office supplies?
 - Senator Gallegos: It is for stationary for workshops.
 - *Discussion:*
 - Senator Goranson: I think their request isn't for very much, so I think we should fund them in full.
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.
- v. Appropriation 10S - Delta Sigma Pi
 - *Sponsorship Speech:* Senator Roybal: They are attending a conference 2/15-17. For line item 1, there was a mistake in the excel sheet but we increased the amount to \$350. For line item 2, their gas mileage was off so we increased it.
 - *Questions:*
 - Senator Torres: Are there any conference fees?
 - Senator Gallegos: They did not request any money for it.
 - Senator Goranson: Are all of them undergrads?
 - Senator Roybal: Yes.
 - *Discussion:*
 - Senator Roybal: MOTION to increase line item 1 to \$350. MOTION was seconded and passed unanimously.
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 18-0-0-2.
- vi. Appropriation 11S - Kappa Kappa Psi
 - *Sponsorship Speech:* Senator Romero: They are requesting money for two conferences. There were a few extra line items, so we combined them.
 - *Questions:*
 - Senator Assed: Why was line item 2 increased to \$1,000?

- Senator AlMidany: Travel per diem is different than travel day, but they requested both on there.
 - Senator Goranson: How many people will be attending?
 - Senator Gonzalez: It is a volunteer process.
 - *Discussion:*
 - Senator Romero: MOTION to increase line item 4 to \$900. MOTION was seconded and passed unanimously.
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 18-0-0-2.
- vii. Appropriation 12S - American Institute for Chemical Engineers (AiChE)
- *Sponsorship Speech:* Senator Romero: They are requesting money to build a car out of Legos and other items, and they need money for supplies. This is really cool what they are working on.
 - *Questions:*
 - Senator Goranson: Does the club have an office?
 - Senator Gallegos: Yes.
 - Senator Lucas: Is the car going to a competition?
 - Senator Gallegos: Yes, it is going to a competition.
 - *Discussion:*
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 18-0-0-2.
- viii. Appropriation 13S - Lobo Hockey
- *Sponsorship Speech:* Senator AlMidany: They are requesting money to go to tournaments out of state and to regional playoffs. They are also requesting money for facility rental for four days. They also need a passenger van to go there, and they provided a quote.
 - *Questions:*
 - Senator Montoya: Can you explain why the facility rental isn't a budget item?
 - Senator AlMidany: Part of this is because they made it to regionals and they were not anticipating that, so it was an unexpected cost.
 - Senator Goranson: Will the whole team attend regionals?
 - Senator AlMidany: I am not sure, but they requested 2 12-passenger vans.
 - *Discussion:*
 - Senator Goranson: I think this appropriation is really well put together and I think we should fund them in full.
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.

- A roll call vote was conducted and the appropriation passed with a vote of 14-1-4-1.
- ix. Appropriation 14S - Circle K
- *Sponsorship Speech:* Senator Roybal: Circle K is a community service group. All of their fundraising goes straight to fundraising. They are attending a leadership conference here in Albuquerque.
 - *Questions:*
 - Senator Goranson: How many other clubs are coming to the convention?
 - Senator AlMidany: There will be 7 other clubs.
 - *Discussion:*
 - Senator Goranson: I think they came in very prepared and knew exactly what they needed.
 - MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 17-0-2-1.
- x. Appropriation 15S Men's Rugby
- *Sponsorship Speech:* Senator AlMidany: They are requesting funds for travels for their upcoming games. They are going to Las Vegas, Kansas City, and Arizona. They are requesting money for gas mileage, travel per diem, and rental fees. They have done bake sales and car washes. They do get some support from their alums.
 - *Questions:*
 - None
 - *Discussion:*
 - Senator Montoya: This is the highest appropriation that we have had this semester. We should be very conscious of the money we are distributing and we should be fiscally conservative. But, I do not see any reason to reduce them.
 - Senator Goranson: I agree with previous senators. They came in very prepared. I feel comfortable funding them in full.
 - Senator Ruja: I would like to know what they were allotted during the budget hearings last spring for rental fees.
 - Senator Gallegos: I do not have their previous budget available, but this is typically what we have funded them in the past. They are one of the highest requesting groups.
 - Senator AlMidany: With rental fees, this is a travel request, which goes in an appropriation. If they received rental fees in the budget, it most likely does not go towards travel.
 - Senator Montoya: What are the standing rules for Finance when it comes to vans?
 - Senator Gallegos: We do not have a cap on vans.

- MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 16-3-0-1.
- xi. Appropriation 16S Something Major A Cappella (SMAC)
 - *Sponsorship Speech:* Senator Gonzalez: They came very prepared. They are asking for money to attend a conference and put on a performance. They have been trying to put their name out there, so they have not made very much money.
 - *Questions:*
 - Senator Goranson: How many people in the group are going on the trip?
 - Senator Gonzalez: 7-13 people.
 - Senator Montoya: Do we fund parking?
 - Senator Gallegos: We haven't in the past, but I don't think anyone has requested it before.
 - Senator Goranson: Are they driving money to LA?
 - Senator Gallegos: Yes, they are driving but they are not requesting money for rental vehicles. They are requesting money for gas mileage.
 - *Discussion:*
 - Senator Goranson: MOTION to increase line item 5 to \$600. MOTION was seconded and passed unanimously.
 - Senator Goranson: MOTION to decrease line item 6 to \$0. MOTION was seconded and passed unanimously.
 - Senator Montoya: Typically, we do not fund events where student organizations charge admission. I think that should be discussed more. For the \$300 for parking, that seems a little too much.
 - Senator Goranson: With the facility rental, I do feel comfortable funding them because they are only requesting \$600 and not profiting off of it.
 - Senator Roybal: With the parking, they brought up the point that parking is very expensive in LA. I would like to hear what people are comfortable funding for parking.
 - Senator Gallegos: For facility rental, we did talk to the student group and told them if we funded them \$1,000 they would not be able to charge admission. That is why they are asking for \$600.
 - Senator Varela: Does the organization do any fundraising?
 - Senator Silva: For facility rental, we gave money to SSE and they charged admission for JID.
 - Senator Torres: For parking, I feel like \$300 is a little excessive, so at most I think it should be \$100 or at least \$50.

- Senator Gonzalez: They are going to California, and it is roughly \$25 per day per vehicle. I do feel comfortable funding them as well even though they are charging admission.
- Senator Roybal: Just to clarify, they are taking 4 cars. They have attempted to do fundraising.
- Senator Gallegos: For conference fees, I think we could fund them in full.
- Senator AlMidany: MOTION to increase line item 7 to \$180. MOTION was seconded and passed unanimously.
- Senator AlMidany: In their appropriation, they said they are expecting to pay \$100 per car for the entire trip.
- Senator Goranson: I feel comfortable funding them in full for parking.
- MOTION to vote on the appropriation. MOTION was seconded and passed unanimously.
 - A roll call vote was conducted and the appropriation passed with a vote of 19-0-0-1.

b. Steering and Rules Committee

- Senator Assed: Legislation is due Friday by 5 pm to the S&R email. If you have any questions, anyone is willing to help you. Please submit legislation!

i. Bill 2S - Gives the Attorney General the ability to make grammatical corrections to our Law Book with permission of the President, Vice President, and Legal Counsel

- *Sponsorship Speech:* Senator Assed: This allows our Attorney General to make small changes through checks and balances, and it would be signed off on.
- *Questions:*
- Senator AlMidany: You don't want this to have to go through Legal Council?
 - Senator Assed: I prefer it wouldn't go through Legal Council.
- Senator Roybal: This is meant to streamline the process, but how long does it usually take?
 - Attorney General Hartshorn: It depends, but it could be up to a few weeks.
- *Discussion:*
- Senator Lucas: There are a couple options when it comes to checks and balances. We have the option if something happens ethically, and we don't approve of the changes made, we have the option to write a bill to change it.
- Senator Montoya: As a previous Senate Aide, I know the ins-and-outs of how it becomes law. Even if it goes to Legal Council, it can be rejected.

- Senator Assed: We should make a definition for grammatical mistake so it defines what the Attorney General can fix.
- Senator Goranson: I think we have to specify what grammatical changes mean.
- Senator AlMidany: From the point of view of a Finance senator, the first thing I thought about was a budget revision. I think instead of the Attorney General presenting it to full Senate, it should be presented to S&R and they would vote on it and then send it to the Vice President and President.
- Senator Lucas: I think we should decide whether to say “grammatical mistake” or “grammatical error”.
- Senator Goranson: I think likening this to budget revisions is a really good idea. I think having a body that is used to voting on legislation is good.
- Senator Silva: I feel like it would be beneficial to have the full Senate see it as well. While S&R has their own opinions, the full Senate does as well.
- Senator Montoya: Grammatical changes are usually fixing spelling mistakes or putting in a comma. That is the argument for not sending it to Legal Council. We would be overwhelming them with small changes.
- Attorney General Hartshorn: I see your comparisons between budget revisions. I think it would be great for the full Senate to see this because we don’t always see the mistakes before it goes to full Senate.
- Senator AlMidany: I think it should go through committee because they are experts on this. Even if it is brought to full Senate, I would not catch anything. I think it would be a waste of time.
- Senator AlMidany: MOTION on line 50 after “and approved” to add “shall be presented and approved by the Steering and Rules Committee” and strike “to the full Senate”. The MOTION was seconded.
 - Senator Goranson: I think we should consider presenting it to full Senate as well.
 - Senator Lucas: While I understand where this change comes from, I do not think this was the intent of the change.
 - Senator Assed: I do feel like changes to the Law Book are important, but they could take time from the full Senate, but it also wouldn’t take too much time. If we do decide to add this, we should get rid of section A. And also fix the rest of the verbiage about full Senate.

- Senator Silva: While I do understand the intent, I think the Law Book is our governing document so everyone should see it.
- Senator AlMidany: I would like to say that I agree that the Law Book affects everyone, I do not think that changing small error will affect my senatorial duties.
 - i. A roll call vote was conducted and the MOTION failed with a vote of 8-11-0-1.
- Senator Torres: I think the best course of action would be to fail this bill so we can define grammatical error in the Law Book.
- Senator Gonzalez: I agree because the definition of grammatical error can be different.
- Senator Gallegos: I think in terms of defining grammatical error we can do that now.
- Senator Silva: I think it would be beneficial to fail this and put a definition in the definitions code.
- Senator Assed: The recommendation to define grammatical error is a fail-safe option. I think having the Vice President, President, and full Senate approve it is enough.
- Senator Varela: I think passing this bill with a subjective definition would be comfortable. I think if you don't know the definition we shouldn't pass this.
- Attorney General Hartshorn: You don't have to put a full definition in the Definitions code, you could put something in this bill. There is only so much I can do with this.
- Senator Jaffe: MOTION to strike the remainder of line 53. The MOTION was seconded.
 - Senator Goranson: I think that because these are changes to our governing documents, I think it should be seen by Legal Council.
 - Senator AlMidany: I am confused why everyone thinks this is important enough to be heard by the full Senate but not by Legal Council.
 - Senator Jaffe: There is no point in sending this to Legal Council.
 - Senator Stearns: The whole point of this is to make this process faster.
 - Attorney General Hartshorn: For those of you who were not in S&R, this was recommended by our Legal Council. I recognize the concerns about it coming before Legal Council, but that was the intent of the bill.
 - Senator Assed: Things have been sent back to us in the past because of one letter.
 - Senator Montoya: Something to consider, because it presented to us at full senate, they have 6 days to sign it

before it becomes official, there would not necessarily be a vote, but if us as Senate see an issue, we can verbally communicate that to Attorney General.

- Senator Lucas: I also think it is important to note, we can talk to Legal Council for advice whenever we want.
- Senator Silva: ASNMSU has something similar in their law book, we want to make sure that this does not alter or confuse the context of what Attorney General changes, they have a section that emphasizes that as long as it does not change the meaning it is okay and further defines grammatical errors and the prerogative.
- Senator Montoya: I think what previous senators have said is extremely value to bring up, but that can be put in our Definitions Code later. There is so much that he just read, I think it can be added later.
- Senator Gonzalez: I would like to hear if people are more comfortable passing Bill 2s with a definition.
- Senator Gallegos: I think it wouldn't hurt to add a definition at some point, but we can pass it now. I think passing it now, we know the intent, and Attorney General Hartshorn knows the intent.
