We are also requesting aprons for our monthly cooking sessions. We have one tomorrow at the Food Lab in Johnson Center, that you are all invited to. We are building this club back up from scratch. We are working on fairs in the spring, and we'll need funding for that as well as volunteer events for



the food pantry that need support. We hope you'll consider that in your decision.

 - 4. Diego: We're UNM MECHA, we're the only group for Latino and Hispanic students outside of HESO. This is our second year of being chartered, the last president may not have asked for funding but I'm the new one and we are.



We're requesting funds to plan events and build community for Latinx students, providing them with opportunities and tutoring. For our last event we spent about 100 dollars on food, and we were very thrifty. We just want to be able to plan events, attend conferences, and establish a presence on campus. We don't have very much and need to do a lot of building. We have some self-generated funds through donations but few. Our event planning is severely limited by our budget which thus limits our membership.

- 5. Sen. Pereira: I was curious, you say food for future events, what might those be?
- 6. Diego: We haven't nailed down specifics yet, but we have ideas: one of them we're planning is a holiday event, one is more culturally specific and will involve food and dancing, and the third event will be a workshop with some teaching and collaboration with other groups and potentially a paint workshop. We're looking into different Mexican artists and may study them
- 7. Sen. Wyatt: Thank you, you said you have some self0generated funds, can you give us a ballpark of where that is?
- 8. Diego: Less than 200 dollars now.
- 9. Sen. Wyatt: Can you elaborate on your existing events?
- 10. Diego: We have weekly meetings that are generally only attended by officers but are hoping to have bigger ones with the approval of this appropriation. Our last big event had between 20-30 students, but the weekly ones averaged 10.

We're trying to have a resume workshop this Saturday for undergraduates and have 30 students already signed up. We have guest speakers coming to that event. We don't have a budget for the event because it's new, but we have 30 people guaranteed and we need food for it.
 - 5. Sen. Wyatt: Could you explain a little more about the guest speakers?
 - 6. Ashish: We have an alumnus who is working at Los Alamos and the other is from Intel, he is the director of planning there.
 - 7. Sen. Pereira: For one event, do we have to cut the food down to 200 or break standing rules?
 - 8. Sen. Carillo: We can make the cuts, but we've broken standing rules for food in the past.

They had a complaint there was no training space, but we're trying to have a space on campus and by establishing this club we want to do it in UNM. That's our reason for establishment and one of the things we will be doing is providing quality equipment for the players to use.

 - Thomas: Hello, I am here to present on behalf of Something Major, we are UNM's acapella group. This gives non-music students an opportunity to sing. We are in the process of beginning a second group and have several different events coming up.
 - 3. Sen. Wyatt: Thank you, I was wondering how many perform with your group at a time?
 - 4. Thomas: On the roster we have 29 people, but with some scheduling conflicts we have between 20-25 performers.
 - 5. Sen. Wyatt: And they'd all perform at the same time?
 - 6. Thomas: No, we have a maximum of 25 people performing at the same time.
 - 7. Sen. Wyatt: Maybe I misunderstood your group splitting?



- 8. Thomas: We are expanding into a second group, a treble choir, and we wouldn't have them on the same stage as us at the same time.
- 9. Sen. Wyatt: Do you have any self-generated funds?
- 10. Thomas: Yes, per semester we can gain about 1000 dollars and have never exceeded that, and we have about 500 dollars in our account right now.
- 11. Sen. Ramsell: Do you have a set location for your equipment?
- 12. Thomas: Yes, both our advisors have space, and we also have a locker.
- 13. Sen. Pereira: Just to clarify, you audition to get into Something Major, right?
- 14. Thomas: Yes.
- 15. Sen. Carillo: So why would every person need a microphone?
- 16. Thomas: I have a lot of experience designing these sound systems, and every performer has their individual means of sounds. We can create a much better balance through our system with the variety of voices we have. With all our outdoor performances, this is the most cost-effective option.
- 17. Sen. Wyatt: I was wondering if we could get some clarification from SGAO on what they have in their account?
- 18. Angela: Yes, they have 508 dollars in their account, and have over 2000 dollars in self-generated funds.
