 - a. Bill 3S Outlining the duties of the legal counsel in ASUNM
 - Motion to open 3S
 - Seconded and passed
 - Authorship speech, Sen. Ratcliff: The main reason we're doing this bill is outlining the duties of legal counsel. So at our correct meetings, we found that the currently the attorney general, if we were to go to trial, the Attorney General is not able to present information or give legal counsel to the student who was there was to get consultation from the Attorney General. So this bill is highlighting the Attorney General able to give counsel, which, in the next bill is talked about a little bit more of what that really is, but it's really being able to present opening statements, closing statements, questioning witnesses, and any other courtroom procedures, calling objections. And so if we look at throughout the bill, you just see that we added or counsel, with counselor and counsel, to really highlight that the Attorney General and the upcoming student attorney position that will hopefully be here, they

will be able to do that. And then in Section 4503 we strike some of the some of the unneeded information that was prohibit. hibiting that Attorney General, from acting and courtroom procedures. Yes, that, that's basically the summary of that bill. Yeah, I really encourage input. If you support it questions if you have any.

- Sen. Hedrick
- Section 4503 where it says advisors are and then, like, comma, therefore, not permitted to speak or participate directly in any hearing. I was wondering, like, would that be something you think would be beneficial to keep like or like why did you take that part out as well.
- Sen. Ratcliff: So in the ending of Section 4503 and Bill three, as it says, advisors are therefore not permitted to Speaker participate directly in any hearing. So is that saying that if someone comes to you asking for your counsel that you're able to technically like deny it, and don't you don't have to talk if you don't want to.
- AG Barragan: If a student comes to them, they're like, they have to give counsel if the case proves it needs to trial. So it would kind of be pointless. The student attorney denies them also. I have to deny students if they're not asunm, because I have to defend only ASun. So technically, I would deny them like, I'm sorry I defend ASun if that's who I'm defending. Student attorney, if the case proves top married and goes to trial, there would be really no point in the nine because it's their entire job to help students. So, I mean, it really doesn't make any sense, kind of the question, how would we kind of fix that. It'll be they can't really deny it's their job.
- Chair Garcia: if because you can't, like deny, or you can't be representing students, because these Attorney General can only represent ASun. Should we strike Attorney General out of this part and just leave student attorney because Attorney General is still in that section for sorry.
- Sen. Ratcliff: Well, I was this says plaintiff or defendant. So for her example, she would be defending the plaintiff and the Attorney General, or, I mean, the student attorney would be defending the defendant.
- Sen. Hedrick: Sorry, that kind of that competing. But my question was more like, does like, are we no longer requiring the plaintiff or defendant to speak for their their own case entirely like they they can't speak on it, only the student attorney or Attorney General can.
- Sen. Ratcliff: They're still able to speak if they would like. This is just saying that the Attorney General and the student attorney is also able to speak if that's what they request.

There is currently a total of 20 members attending, so 14 round trip flights would need to placed. It is also worth noting that the price of a round-trip flight ticket to and from New York City will be higher by the time that the earliest funding will be available.
- The same 20 brothers that are attending the networking trip to New York City will also require funds for not just food, but lodging as well on the nights of April 4th and 5th. At most, we can fit 4 people in a standard hotel room, which would mean that we would need around 3 to 4 rooms to house all 13 brothers. It is more reccomended to rent out an AirBnB for the members to stay in during those 2 nights.
- T-shirts. We currently do not have any cohesive clothing for our chapter, and would like to make a more formal/uniform look, especially for community service events and travel. We are looking at buying t-shirts through Greek Gear, but will also compare prices with other companies to ensure best pricing.
