a. Appropriation #2S - [UNM World Affairs Delegation](#)

DETAILED DESCRIPTION

- CHOMUN - Flights to Chicago. We are requesting funds at the 70% reduction as allowed by finance committee standing rules. Averaging quotes from Delta, American, and United, we anticipate a cost of \$794 a ticket.
- CHOMUN - Conference Fees. Regular conference delgation fees range from \$95 to \$100 for the UNM delegation depending on the time of registration. With registration before Febuary 7th at \$95, and registration after Febuary 7th at \$100. Additionally, each registered student adds a Delegate fee of \$100 to \$110 dollars. With registration befor Febuary 7th at \$100 per student, and reigstration after Fubuary 7th at \$110.
- CHOMUN - Lodging and Per Diem. Reistration to CHOMUN includes a discounted rate to the Palmer House Hilton in downtown Chicago. The special rate is \$190/night for a four-person room. As we will need a total of 4 rooms to accomidate 16 members, we are asking for a per diem of \$280 per day, for 4 consecutive days
- . CHOMUN - Team Dinner. At each conference the World Affairs Delegation puts on a team dinner to celebrate the acheivements and efforts of our members. At these dinners, a spending limit is given to members, and any extra costs incurred above the spending limit is paid at member expense.
- World Affairs Delegation Weekly Meeting. To reward regular attendance and commitment we are requesting the maximum \$250 dollars for food and refreshments for team meetings. These funds will be focused towards days when members have to stay for several hours at conference workshops and writing background guides.
- World Affairs Delegation Special Events. Recruitment is a critial goal to ensure the World Affairs Delegations long term success. In order to help attract potential members, we are requesting \$400 in funding for light food and refreshments to provide at recruitment events.
