**DETAILED DESCRIPTION**

- ISA is planning to host outdoor sports events in future primarily at Johnson Field and Gym. Cricket, one of the most popular sports in India, along with badminton, volleyball, and pickleball, will be featured. ISA intends to purchase kits for these sports and organize friendly matches among UNM students. Additionally, ISA plans to collaborate with other UNM student organizations that have their own teams for these sports.
- ISA is requesting \$158 to purchase two 6-foot table booths for use at campus engagement events, such as booth setups at SUB or Duck Pond, as well as for various outdoor ISA events throughout the year.
- ISA is requesting \$110 for a large cooler box to store and keep beverages, such as canned drinks, cold for extended periods during larger events.
- ISA is requesting \$90 to purchase two portable sports cooler. This cooler will be used at the event to dispense water, making it easily accessible to attendees while also helping to reduce water waste.
- ISA is requesting \$500 to purchase a canopy tent for outdoor events. ISA will use the tent in one of the main events, Holi at Johnson Field, for registration, food service, and other activities. Additionally, the tent will be utilized for various outdoor events, including friendly sports activities mentioned earlier.
- ISA is organizing Holi in collaboration with Hindu YUVA and the Nepali Student Association in April 2025. One of the major expenses for the event is food. Hindu YUVA has already received \$800 through ASUNM Appropriation, while the Nepali Student Association has not received any funding. Therefore, we are requesting to cover the costs.



- ISA is requesting \$250 to cover the cost of essential event supplies, including vibrant color items to enhance the festive spirit of Holi, as well as disposable paper plates, napkins, plastic utensils, buckets, wrist tags, some squirt guns, forks, plates, spoons, and knives to accommodate attendees. These supplies will help create a colorful and engaging atmosphere while ensuring smooth food distribution during the celebration.
- ISA is requesting funding to cover the rental costs of essential equipment for the Holi celebration, including 2 tents, 5 tables, 4 trash containers, and cord covers as discussed with GEO. These rentals are necessary to ensure an organized and enjoyable event, providing shaded areas for attendees, designated spaces for food distribution and activities, proper waste management, and safety for electrical setups.
- ISA is requesting funding to cover banking fees for our events. Each time ISA uses their any fund, a 4% transaction fee is charged on that. For example, at the last Bollywood Night, ISA generated over \$3000, but nearly \$150 was deducted as a processing fee. To prevent this financial loss and maximize our event budget, ISA is requesting funds to cover these fees.

#### DETAILED DESCRIPTION

- Spring 2025 Rose Gala - We are requesting the funds necessary to reserve a venue in order to host semesterly Rose Gala event in May which recognizes our current seniors, their accomplishments, and a last-goodbye event before they graduate.
- Spring 2025 Rose Gala - We need to provide food and beverages for all of our members and alumni to enjoy during our Rose Gala



event. The amount of people that usually attend is between 60-90 people, which includes catering and service charges as well.

- The chapter is planning for a trip to New York City, leaving on the morning on April 4th and returning in the afternoon of April 6th. For the networking and meet-and-greet/Q&A trip in New York City, we would need the required funds to fly to New York on the above dates. There is currently a total of 20 members attending, so 14 round trip flights would need to be placed. It is also worth noting that the price of a round-trip flight ticket to and from New York City will be higher by the time that the earliest funding will be available.
- The same 20 brothers that are attending the networking trip to New York City will also require funds for not just food, but lodging as well on the nights of April 4th and 5th. At most, we can fit 4 people in a standard hotel room, which would mean that we would need around 3 to 4 rooms to house all 13 brothers. It is more recommended to rent out an AirBnB for the members to stay in during those 2 nights.
- T-shirts. We currently do not have any cohesive clothing for our chapter, and would like to make a more formal/uniform look, especially for community service events and travel. We are looking at buying t-shirts through Greek Gear, but will also compare prices with other companies to ensure best pricing.
- Occasional food for the general weekly meetings of the chapter on campus
