President Stokes and Provost Holloway

Garnet Stokes

- We are very happy to be here! It's that time of the year where it's getting pretty busy on campus. There is a great deal going on for the university leadership. It has been a time of incredible pressure for higher education institutions. I made a statement in front of the board of regents yesterday. It's unlike anything I've ever seen in my lifetime. It consists of many executive orders.
- The most important thing I want to say is that we will remain dedicated to the mission of UNM. To serve all New Mexicans and create new knowledge. Another thing we are very dedicated to is the way we deliver education dn healthcare. We have been here for 130 years. We have worked through problems and we will work through this one too.

SEN ROMERO: It's an honor to have you here! I myself am a recipient of The National Hispanic Scholarship and is there a possibility that there will be changes in my scholarship?

PROVOST: We can't say how but we are sure that there will be changes in our National Merit Scholarships based around race and ethnicity. One of the ways that we are working with scholarships like that is by creating scholarships that are intentinde to support hispanic student learning or the rich diversity of new mexico. We could try to focus the scholarship on the intent of the recipient.

SEN GARCIA: In a similar realm, I know there are alot of students that rely on lottery scholarships and on the tuition side of it, what direction are we headed for?

PRESIDENT STOKES: To support the longevity of our students, the lottery scholarship has built in a buffer that will allow increases of tuition fees and admission growth. We have no reason to believe currently that the opportunity or lottery scholarship is at risk right now.



SEN TRUJILLO: Thank you for coming to directly speak with us, regarding resource centers on campus. Do we know if they are at risk of being ripped from campus and what can we do to protect them?

PRESIDENT STOKES: As the Provost alluded to earlier, we are here to support the students of the university of new mexico. Resource centers are the best at doing so. We believe that these centers are serving an invaluable function for students in their navigation of student life and inclusion. At this time I don't expect any of our centers to see major loss of funding but members of our executive legislative branch are watching out for this issue right now. I won't pretend that I can predict the future. There will be a time of more clarity of what's percieved at legal versus illegal in coming time but we are not like other universities in the country. We are the first Hispanic serving flagship university. We need to look at the state we serve asweell. There are ways for us to navigate this together.

SEN RATCLIFF: We as a student government are always constantly looking to better the campus as a whole and the way our student government is structured as a whole we try to be self serving and we can only do so much to speak to influential leaders on campus but I think there is a better answer of what we do better for the campus.

PROVOST: Yall are doing a great job, keep doing what you're doing. With that being said, you all have the opportunity to display student leadership in every action you do for this campus. One thing we have been trying to work really hard to do is to try to give a vibrant student life on campus. All those things are really important and many of the services we offer are not utilized to their maximum capacity. Each one of you as individual leaders can just get others involved. Don't recruit eachother but recruit them from your math class or just people you see day to day. When you talk to students you should be known as senators so that when you advocate for them to get involved or to take advantage of the student resource centers or go to the football games, that's separate from your legislative duties but just giving back to your university as much as everyone should.

SEN MCCLOUD: Thank you for coming today, the board of regents made some proposed changes to its policies, how should students interpret that information?

PRESIDENT STOKES: We have committed to only doing things that are clear and actionable. It is clear that we have a policy that we can now clearly recognize as an illegal action. We have to



get our language right and our policies in line. What this really means is that there is a different word on a paper. There is not a great deal of concern that there will be change due to language change in regents policies. I will say again that we are wanting to support the success of the people in New Mexico and the diversity of our institution aT every level matters a great deal. There are pathways to achieving that and we have found it easy to do this work despite an affirmative action policy on paper. We have been practicing how we support students the best way we can and focusing on our hiring processes and the diversifying of pools in our institution.

SEN GONZALEZ: Can you characterize the university's efforts to protect undocumented and international students?

PROVOST: Firstly, knowledge is power. We have held many training sessions for our students and faculty to know their rights about their education. Our global education officer also has been pushing efforts into protection of our students and we do not collect information about documentation status for all students. We do this purposefully. To avoid information that could bring risk. Opportunities for exposure are not in our mission. We're working diligently on a case by case basis for our students.
