Attorney General Peacock, because the specific wording is not in the lawbook yet. Attorney General Peacock presented two edits concerning the law book. Both edits are inside the legislative code. The first edit occurred in Article Two subsection two clause F, changing the word "of" to the word "for". This concerns the President Pro tempore not counting as a member of quorum for any committee unless not enough members of the committee are present. The word "of" was the incorrect preposition for the phrase and the Attorney General is allowed to make the change as it is simply a grammatical error. The second error that was corrected was in Article six subsection one, he removed the "s" from regards changing it to regard.

h. ASUNM President's Report

i. President Pacheco: President Pacheco expressed her gratitude for everyone that came today and her excitement for everyone who is involved with Senate. She shared some updates from her end. With the chief of staff and Vice President Chessman, worked to establish a solid foundation for the year. There are three new positions: the Director of Student Wellness, Director of Environmental Affairs, and Director of Student Org Relations.
