- B. Preliminary Business
 - a. Chair
 - i. Chair Zinsmeyer: Yeah guys, Good productive pre-SNR. Thank god, like always. Make sure you bring up our thoughts during preSNR. This is to make sure that they get in the minutes and how we got to where we did three four five years from now. That being said, nothing else, lets have a productive meeting meting and be efficient.

 - c. Public Comment
 - i. Alex: I've met some of you but not of you guys and it is nice to see people I haven't met yet. I am currently the Director of Governmental Affairs but am not here in that capacity. I am here because I submitted legislation



that has been sponsored by Sen. Hlaing. I have been submitting this with AG Barragan and Sen. Pingal. This legislation tries to fix a disparity we seen. We do not have a fair legal process, we do not have a court process that allows fair representation of the people. I saw this because I have talked with justices, chief justices, previous AG's current past senators, and a lot fo people and where our system is at and how it can be improved. The consensus I have heard is that this is not a fair system in terms of case representation. To do fix this we have two ways: Getting fair representation in court through creating a public defender position, and cross-examination. As it stands we do not allow cross examination. Meaning if I have questions about anything that was just brought up during direct examination, I cannot ask any questions based on what the defendant said, without writing it on a piece of paper and hoping that they are accepted. Phrased in such a way that preserves the meaning of the question and are answered. If not answered I get zero follow up. There are a lot of great examples of this, best example is witness impeachment. If a person comes up and says "Oh yeah there is this person and they are very rude in the office and did nothing but mean things all day" I have zero standing to ask them to elaborate on this, what did they do that made you think they are in a horrible mood. There are so many questions to be asked for elaboration. I cannot now ask a question about this person or anything else. This is a fundamental legal aspect that we see in the real world, but again we do not allow that. I have heard a couple arguments such as that we are not a serious argument and a serious government. But there is also the other side where that this is a serious topic and this is a serious government. I believe that we are a serious government and a legal body, this is why we follow OMA and why we have restrictions. Our point of arbitration is the student court. They are our arbitrating body. We cannot say we are not a serious body, and this is not a serious court and shouldn't have serious laws. That is how we get the flawed system we have today. I ask you guys I am going to be submitted this bill here and have submitted amendments that have gotten support. I ask you guys to look at these amendments and pass these so we can have a serious and fair court.

- ii. Alfred: I am an associate justice and wanted to add support for this bill. I think that this bill will add a much-needed dynamic to the court that is missing, but I do know that it has its flaws and advise you to refine it an pass a quality bill. I also know that it would be a big step in the right direction. I know that the pervious speaker mentioned that there are issues but it will be a movement in the right direction.
- iii. Juan Romero: Current chief justice, I wanted to make my remarks about a public defendant. Form a student court the system is not fair. Right now



ASUNM is protected, while students do not have that. If we want to be fair we need to provide students with a public defendant. A lot of students are afraid to do anything because they know they are not going to win, it is not fair. We need to pass this bill. Not how it is currently though. I want to emphasize that if we want to be a fair government we need to have a public defendant for students

- iv. AG Barragan: I want to re-address what I said during preliminary. I highly suggest three options that we discussed, one and two are the best. Two would be great, and one is not the best. I am looking at the bill right now, and I don't see something that I think is hevily argumentative on, is preapproved questioning, we already have pre approved questions for witness. There are worries of badgering, and lets say you bring up a question that is sensitive it can lead to emotional trauma. I would emphasize pre-approved questioning, and that is all.
- VP Jaber: in 2023 in the fall session I was a senator on the SNR committee and legislation that we wrote at the time was very similar to this bill which was to add cross-examination to the law book. As soon as I discussed this with others I realized how this bill can be pretty controversial. I think that ASUNM should provide a safe space for students. If there is a student court case with two students who at the end of the day we are not a court. Lawyers are taught how to use the law and be a lawyer, and that is something we cannot guarantee. That can raise a lot of tensions and questions that are inappropriate towards the opposing witnesses. I do think there is a need for something in the court that does involved this. It does need to cook a little longer to get a consensus and that we are not leaving anything open ended. Even if you hire a public defendant for this position and an AG you cannot guarantee they are trained on this topic. I am talking about bill 9F and adding something to approve the questions by the court and is something I looked into when I wrote the bill. The thing about cross-examination is that those questions come up on the fly, and they would make the court case longer and we thought it was. Do i think this is the correct way about going about it and I do not think that it is. I wanted to share my opposition to bill 9F
- d. Chair Zinsmeyer speaking on behalf Ryan Linquist: Hi all, I wanted to touch base with you about Bill #9F since I will not be able to attend S&R on Wednesday night. I am very opposed to this bill. Allowing counsel to do direct and cross examination would not be good for the ASUNM court process. As it is now, having questions submitted to, approved by, and read by the court takes the emotion and debating skill out of examination. The current process keeps the trial and court focused on the issue at hand rather on who is better at conducting examination. Allowing examination by counsel turns the trial into



who is better at grilling and tricking witnesses. It allows for personal feelings and attacks on people. This would turn a court case into a bigger spectacle than it already is. Cases should be about the topic at issue and not about who has more experience in a mock trial/WAD environment. Questions introduced, approved by, and asked by the Court allows for this difficult process not to be even more terrible for those having to go through it. I would suggest you talk to anyone who has had to go through this process about the impact this would have on them and the process. I went through two ASUNM Court trials as a student (ASUNM Election Chair for two years) and I can tell you this would have been horrible. ASUNM Court is not a court of law. Court of law counsels and judges have years of schooling, have to pass the BAR, and agree to rules of professional conduct. None of these items are required for counsel or justices in ASUNM trials and this would create chaos and something the court would not be prepared to handle or mitigate properly. The current ASUNM Court process has worked for well the over 30 years I have been on campus and this is a change that will not make this process better. How does this change make things better for all sides, and the Court Justices, if it is adopted? I feel it would only add drama, stress, and pain to the process for all involved. It only makes it better for people on the outside who are pulling strings to create a real-life TV court drama. I am very opposed to these changes to the ASUNM lawbook.

- e. Protemp Montoya: Speaking on bill 9F as I stated during preSNR. I am in favor of cross examination, however, I do think there is a significant amount of work that needs to get done, I do think this bill should be failed. One thing in my opinion that should be considered when decided to fail this bill, is emotional damage or trauma. The court is not the only place for this happen. This can happen anywhere and does not need to apply to this bill, and I yield.
- f. President Tomaziefski: I agree with the statements made by others, and this bill does not take into account the emotional status of a student. Being grilled by an AG is not something anyone wants to go through. I feel that going through with this bill can hurt ASUNM

- D. New Business
 - a. <u>Bill #8F</u> Adds organizing UNM Day to responsibilities of Governmental Affairs Executive Director, strikes Cornell Mall as a legislative priority.
 - i. Chair: Motion to open bill 8F
 - 1. Seconded and passed
 - a. Authorship speech: Sen. Hlaing: This bill places the organization of UNM day, a one day trip to Santa fe, the responsibility to organize this under the director of governmental affairs. It has already been like this, and it is made official within the bill. This bill also strikes out section 2604, which says that the Cornell Ampitheater



would be the priority for capital outlay projects, and that is because priorities have changed. Such as period products and potential accessibility fixed with Johnson field.

2. Discussion

- a. Sen. Garica: I am very much so in favor of this bill. Simply because of the fact that it should be offically placed in teh lawbook even after we have served our time.
- b. Sen. Ward: I am also in support of this bill in terms of the capital outlay and how it really should not be in the lawbook. I am a big fan of being specific and organizing the lawbook.

- b. <u>Bill #9F</u> Amends the current court procedures to allow for individuals to more properly question witnesses, and expands on the rules of evidence to reduce confusion and contradiction.

 - i. Authorship speech:
 - 1. Sen Hlaing: While i am not the author I am a sponsor. This bill would add two things. The original bill would add the process of cross-examination, and a friendly amendment adding a role of a public defendant to defend the plaintiff against the AG.

ii. Discussion

1. Sen. Ward: I think we have had a lot of discussion on this through preSNR and public comment. I want to voice my opposition to this bill. I have to agree with Ryan. It makes a spectacle of the case rather than being it fair. If it was really about fairness it would already be brought up and had more conversations about it. I got the email the day before it was submitted for revision and that is not enough time to review it. I am all in favor of fairness, but I do think that is a discussion for another time. I do think that adding the position of student defender position, I do not see the point in that, usually we have a



- defender for ASUNM. The student court handles infractions through lawbook, where the ASUNM person is being targeted. Thats all I have.
- 2. Sen. Garica: I would like to voice my opposition to this bill. I do think that adding cross examination is important, but not in this way. I do also think that adding an amendment this late is not enough time to review and change things and debate things. I would like to support my voice in failing the bill and working on it. I know that we are a serious court and government, but we need to treat the legislative process with seriousness.
- 3. Sen. Hlaing: As an SNR committee we have the ability to add amendments and work on the bill while it is on the floor. I would encourage senators to not look at this to introduce drama, but rather the opportunity to elaborate on comments made. For example, if a witness says this person was unfair to me or treated me differently, it gives opposing council to question. The bill also contains a lot of additions in the rules of evidence in clarifying what hearsay, leading repepative questions are, and etc. This provides more clarifications and people are able to raise questions. I think that this does give us the ability to review during committee
- 4. Sen. Hedrick: I do agree with this bill and that it is not inherently bad, it just need to be reworked in its entirety
- 5. Sen. Ward: I don't think that we can productively and effectively change this in committee, and I think we can work on this outside of committee. I do believe that ASUNM is serious and the court is too, but in no way are the members trained lawyers and judges, it is also not placed in the law



book and leads to complications.

- 6. Sen. Hlaing: Several senators are saying there is room for improvement. I mentioned during public comment something that would alleviate the drama and the possibility of pre-approved cross-examination. I would love to hear this improvement from the committee and why we cant work on it here.
- Sen. Garcia: Even working on this bill here, there is very much so many more conversations that should take place outside of this room. I do believe that it would not finish tonight and pass in full senate.

a. Appropriation 19F - Health Professions Symposium

- Food for the HPS Event on April 12th 2025. This year HPS will be held on North Campus, around Domenici Center. North Campus does not have a place where food can be readily available, resulting in having to cater from a restaurant. We request the maximum amount of money for catering the HPS event to be able to feed around 1,600 registrants, the presenters, and healthcare professionals that attend the event.
- Food at our biweekly HPS meetings to feed our dedicated members who work diligently to plan this event. Food for our event costs around 10,000 dollars. We at HPS are aware that ASUNM funding is limited, but that means our funding for food cannot go towards providing for our hardworking team. Additional funding would be greatly appreciated for the HPS team.
- Food for events that we hold for professional development. This is essential for strengthening pre-medical students' resumes and for professional growth. We plan on holding two professional developments this semester.
- HPS has received little to no money for advertising in the past. Receiving this money would go towards buying social media ads and advertising to local news networks such as KRQE. Advertising the event is a crucial contributor to getting the word out and allows us to reach as many students as possible to share the opportunities and resources that we offer.
- For our events, we would like to have collapsible wagons. On the day of the event, we handle a variety of tasks that involve moving and transporting numerous items, such as cases of water, boxes of tote bags and office supplies, banners, and more. Having these wagons will help reduce the number of trips and expedite the setup process, making it more efficient and ensuring a smoother event.
- Similar to advertising, we have received little to no funding for promotional materials. In the past, these items were zeroed out in our budget request. We are again requesting promotional materials such as pens, stickers, and candy to have at our tabling events. Our team works hard to travel to high schools to meet with advisors and students. Having promotional items to hand out allows them to have something tangible to remember us by and a greater chance at



attending our event.

- Renting chairs, tables, and tents for the day of the event. The Health Science Center has explained that they only have a limited amount of chairs and tables and we will need to rent more for outdoor seating as the HSC indoor seating is not adequate for our typical amount of attendees.
- Conference fees for the International Conference on Diabetes, Obesity, and Endocrine Diseases (ICED-25) in Seattle, WA. The conference offers valuable professional development through access to the latest research, expert insights, and networking opportunities. We are members and will be getting the discounted price.
- This is the ICD OED-25 conference that will be taking place from January 11th through the 12th. This conference is for professional development which is essential for our organization to network and learn more. Receiving this money will allow us, as an organization, to better serve New Mexico as a community.
- Per Diem for the Seattle conference. This is for January 10th to January 16th. We are feeding 10 people for 6 days during the conference.

- Hotel rooms for six members (will be three to a room and will split a room with other student leaders) for 3 nights. Rooms are \$216 per night plus taxes for an estimated total cost of \$1,900 for three rooms. Due to the cost of the hotel, we will be providing our own food costs.
- Round trip flights for six students to Indianapolis, Indiana (IND). Reduced request in accordance with standing rules. Current lowest cost on UNM's travel site for flights is \$370.96 each on Southwest. Six flights x \$370.96 = \$2,225.76 x 70% = \$1,558.03. We also explored the option to rent 12-person vans and drive which was nearly double the cost of flights for the entire delegation.
- If we are able to register by January 18th, registration costs are \$329 per member. In accordance with standing rules, we are requesting 70% of this amount up to the maximum of \$1,000.

DISCUSSION AND QUESTIONING

SEN GONZALES: Referring back to line item 15, could you outline those items a bit more? Representatives answered mostly with pens and brochures.
