 - ii. Kadra Guillerme: So today I'm asking for an appropriation of \$1,325. We are asking for \$300 for food for meetings as the largest free medical group on campus with about 60 members that are active. It is expensive to feed students and our meetings are during dinner time. So we are also asking for \$800 For our end-of-year banquet. So this is to celebrate students achievements throughout the year and recognize our community members and sponsors. And so we will also be requesting \$75 for printing supplies and then additionally requesting \$150 for office supplies.

 - iii. Gareth Ripol: I'm the president of the Student Veterans of America at UNM. And I asked for an appropriation for money for airfare for travel to our national convention. In Nashville, Tennessee. The national convention, the NATcon is a place where universities from all over the country have their SVAS representation And we attend workshops. We work on synergy between universities and collaboration. The NATcon gives us an opportunity to speak for legislation for the GI Bill reforms, and any sort of veteran education reform that needs to happen. That's our opportunity to lend our voice and it all comes back to the community here at UNM so that we can institute change. We also at the national convention attended workshops on inclusivity. Changing the community making it comfortable for student veterans to be just to be included. And we do away with old shouldn't say old passe policies that do not allow a student veteran to thrive. So that is a Natcon.

 - 2. Gareth Ripol: 3 people
 - 3. Senator Fetherman: With the quotes that you submitted for American Airlines the flight cost was 496 and Delta was 447 dollars. But on your appropriation, you have one unit for a price of 588 dollars. HOw did you arrive at that number
 - 4. Gareth Ripol: I called someone at the SGAO office, and asked if I could just use southwest airlines as the

one airline or do I need to list all the quotes. She said that I could just put southwest.

- 5. Senator Fetherman: But then, since I see two screenshots from Southwest but neither of them have the seat price. American does and Delta does. So I guess I'm just confused was the seat price for Southwest 588 or was that all three of the seats?

Ariana Egure: We are an organization that wants to promote unity and space for chicanx and Latinx undergraduate students and bridge the gap between chicanx and latinx high school students and university. We are requesting approximately 2500 dollars. , I believe that the most important funds for us would be the conference and food and the banner, and we would be willing to cut 2000 for professional services.

- Senator Fetherman: You requested food in multiple categories, is there a large event that the food is going toward
- 8. Ariana Egure: In November, we are hosting a food drive and we are going to invite chapters from different high schools to come and kind of like pay for them and cover the food cost for them as well.
- 9. Senator Guttierrez: You said you would be willing to cut the professional service. Would you be willing to cut that to pay more for the travel?
- 10. Ariana Egure: Yes.

 - 3. Point of information: What we discussed earlier was to cut line items missing quotes to zero. However as this group prioritizes travel, wouldn't it make more sense to fail the appropriation?
 - 4. Chair Schultz: But there are still line items that don't require quotes, so I am not sure that is equitable.
 - 5. Senator Tomaziefski: But if we failed it entirely, they still could come back this semester with a different appropriation.
 - 6. Chair Schultz: Let me check on that.
 - 7. Angela De Avila: Each semester each student org is only allowed one appropriation, so the only way that they could submit again is if this appropriation completely fails.
 - 8. Senator Tomaziefskii: So they still would be able to get their funding if we failed this and they came back with a different appropriation that had the quotes.
 - 9. Chair Schultz: However, they had sufficient time to submit the quotes We can also table this and come back to it if you would like.

- 10. Senator Fetherman: I did not remember that they had not submitted quotes for the conference fees or the airfare. I would be willing to table this for later. I know that they've had ample time to submit quotes, but I think that a previous senator suggested failing the motion so that they would have another chance to submit it this semester. And another chance for funding is a very compassionate suggestion, which I would be willing to explore especially since we haven't been funding things without quotes.
- 11. Senator Guttierez: So with that, all the people who previously submitted appropriations for travel, I felt like looking at past precedent will be very key here. So I felt like failing it, would it really make any sense.
- 12. Senator Tomaziefski: To address the comments of another senator, who would be the precedent is that quotes I mean, unquoted items would be cut from or struck from the budget. So funding travel for other clubs that precedent is that they have to quote instead. So given that this appropriation wasn't filed with quotes, it would be able to give them another chance to submit an appropriation request for later in the semester.
- 13. Senator Grado: I also think it'd be a good idea just to table so we have more time to come back and really assess what it is. I know like you've said that we haven't funded people who haven't gotten quotes. But there have been some instances where we have done that. And so I just want to make sure that we are again, setting the precedents and everybody's being equal. So yeah, I would be open to tabling and then coming back to discuss it later. And with that, I yield Thank you.

- d. 18F- American Institute of Aeronautics & Astronautics
 - i. Motion to open appropriation 18F
 - 1. Seconded and passed
 - ii. Luis Quintana and Erin Lawlar : And we are really coming to you guys. Because our club has been at UNM for quite a long time. But of course COVID kind of kicked us down quite a bit. In the past couple of years. We haven't had that much

funding. We did miss your appropriation budget times because we've had so few members. So this year we've really been working in and last year we get to more members. And this year we finally had enough and excitement around it to hopefully get people more connected to the different aerospace industries that American Institute of Aeronautics & Astronautics is all about. A little bit about air ws national organization is that they're a professional club for engineers in the aerospace engineering industry. So tired and a lot more with the state and national levels of the group to go to some of their events and stuff. There be our main thing is getting aerospace opportunities to the undergrads in engineering school. We have a mechanical engineering department, and most of our members come from that. But there's no airspace classes or majors for undergrads. So our club is kind of the only route for them to go into that to get like experience before actually getting a job in aerospace. So our biggest asked from you guys, and our appropriation, which is planning to go to a conference. It's the biggest American Institute of Aeronautics & Astronautics conference in the nation. They called it annually. And so it would love for our members to go get connected and really get to network with the actual organization.

 - 1. Senator Grado: Can you talk more about the drone? Are you building one?
 - 2. Luis Quintana and Erin Lawlar: Absolutely. Okay, so our club just a bit of kind of rocket and plane club, anything that flies. So we've last year got an appropriation from you guys to help you have each member build their individual rocket. And this year a lot more of our like freshman and sophomore. members who have just joined ever bigger interest in the drone aspect rather than just the rocket aspect. So we were hoping to get supplies to get a drone as well all the parts of the job, and then as a client work through that in the semester to actually build up and construct this.
 - Senator Guttierrez: Will you be giving out the shirts? Will they be stored on campus? Because Unm is anti donation so shirts that we fund can not be given away or sold.

- 5. Senator Schultz: Are you comfortable giving it to members and then return and only wearing them at events and stuff like that?

- 9. Senator Tomasheski: Do you charge member dues?
- Luis Quintana and Erin Lawlar: No we do not. We have

- 12. Luis Quintana and Erin Lawlar: It will remain on campus.
- 13. Chair Schultz: Drones can not be flown on campus, so where will you fly them?
- 14. Luis Quintana and Erin Lawlar: We are partnered with the Albuquerque Rocket Society so we will fly them to their location.

 - b. Discussion
 - i. Senator Tomaziefski: I know that we are funding everything to standing rules. I know that we are funding at slightly lower rates.
 - ii. Senator Grado: I would like to bring up to the committee to not fund the drone at the full amount.

- 16. Senator Guttierrez: With our budget, what would the committee be willing to negotiate?
- 17. Senator Tomaziefski you look at the list that they provide and say about it, I would say about 65% of it is just like equipment and drills, etc. If we if we don't find the big ticket items that are also just digital technology, like the drum kit for the FPV goggles is \$329 which reduces the total of the line item to buy from some team which I think is more reasonable than just \$0.
- 18. Pro Temp Gurule: Thank you. So back to what you said so far. This is a lot of the equipment I think if you're looking to cut something from it you can cut the equipment because we can I'm sure there are supplies like that on campus. So supply the materials that absolutely must be purchased. And then any equipment like like like a hot glue like heat gun or glue

gun stuff that commonly around campus could most likely be cut but that.

- 19. Senator Tomaziefski: I recommended to fund the equipment that they requested but not fun word drum kit which I've got \$400 The goggles \$90 And then the radio transmitter at \$200. Instead, we can do the opposite as previous recordings those pieces of equipment are easier to find on campus. So we can instead fund the drum kit and perhaps the radio transmitter at \$79 instead.
- 20. Senator Featherman I think like the previous suggestion of funding the rare hard-to-find items for the drone is a really great one. I however would like to go through the list and see which items the Senator would want to find just because I'm having a little bit of trouble following
- 21. Senator Tomaziefski: So I wouldn't recommend finding the drum kit which is in line five of their provider list, and also the radio transmitter line 21. The rest I would include other equipment that they could find on campus or they could just be something they might have to purchase with their self funding
- 22. Senator Grado: So looking at the list that they provided, and I am not a astronautics person. Maybe we could ask the board what is the ones that are the hardest to find that will we know like okay, this is what they're gonna need. And then like I like with everything else. We can cut like the glue gun and the heat gun and stuff like that.

- Ella Thomas and E. Marquez Our appropriation is for \$1200
 We are just looking to cater the remaining events for the rest of the year. We will have more this semester and 4 more meetings next semester, and it costs about 200 per meeting.
- iii. Questions
 - 1. Senator Gutierrez: How many members?
 - 2. Ella Thomas and E. Marquez: 20 people at our meetings
 - 3. Senator Grado: What does a meeting look like?
 - 4. Ella Thomas and E. Marquez : So we have regular meetings once a month. We kind of change up what those look like usually our first and last meetings of semesters will be just social gatherings for Anthropology undergrads. To just come hang out, and talk with each other. Just talk about anthropology and exchange information about classes, fellowships, grants, things like that. We also have faculty speak at our meeting. Sometimes they'll do a lecture and a q&a. And that allows students to get a little bit more one on one time with them. And then we also occasionally will do things like game nights that are just meant to kind of bring the undergraduate anthropology community together.
 - 5. Senator Guttierrez: What are your priorities?
 - 6. Ella Thomas and E. Marquez: But for example, right now we're planning a meeting that we probably would not get catered in collaboration with the Maxwell Museum and the Chicano. Studies department. But definitely meetings over events and also our catering costs does tend to fluctuate per meeting depending on you know, what specifically do you order?
 - 7. Senator Tomaziefki: When will events be planned?
 - 8. Ella Thomas and E. Marquez: There probably wont be a ton for this semester, but there will be more for next semester

 - 2. Senator Tomaziefski: I would love to hear other senators opinions. Appropriations are used for one time capital outlays and not budget items. Additionally, if the event for the event is funded next semester, is under this student

organization we be able to receive more funding and if we strike this line item.

- 3. Senator Fetherman: I agree with the sentiments of the previous senator. I think that if we fund line item eight, as it is now cut to standing rules, cut line item 15 and give them give this club the opportunity to request more food more money for more food for events next semester. There's a much better chance of them receiving more funding. But I would also like to hear what my fellow senators have to say about that.
- 4. Senator Angel: I wanted to say that I am in a position to fund food events. I feel like food draws a lot of people to events.
- 5. Senator Fetherman: I think that the previous senator brought up good points, maybe we could cut it down and not fund it completely?
- 6. Pro Temo Gurule: I encourage you to inquire and cut to the number of meetings they have left this semester.
- 7. Senate Tomaziefki: I would agree with previous sentiments if we just look at this semester.
- 8. Senator Grado: Again, as the sentiments of my previous senator said I would agree with funding line item 15 at a smaller amount. My only concern with that is it does again break standing rules for what we've been giving people and so I just want to since we are cutting their food for their meeting, maybe leave the food for the event. But I would like to hear what my other say.
- 9. Senator Tomaziefki: What standing rule would that violate?
- 10. Senator Grado: Excuse me, not a rule but precedents.
- 11. Senator Tomaziefki: I would also like to echo what we said in prefinance where, of course, we have our president, but we also are challenged with the fact that we have a restricted budget, reducing the line increases the amount of money we have to give students for events the semester.
- 12. Senator Featherman: I would just like to say that because this event that they're planning is next semester. Once the spring fees kick in, they will be welcome to submit another appropriation we could give them more funding for food than they're requesting here. So I think that we should cut line item 15 and make it extremely clear how to request the

most money that they can get for the event that's happening in this brain and save this money for student organizations who haven't submitted their appropriations yet for an event that will happen this semester.

Senator Angel: I think the precedence that we've been setting is that we've been funding food at the greatest capacity and it is the Associated Students of Students government issue that we are limited in funding, not the student body. So in that President, I think we should find it as is and then you should leave it as is and I think that is it, honestly.

A lot of that's just been because we pay for everything ourselves for printing we are requesting about \$50 Because not sure that's how

much it will cost us. It'll probably cost less than 20 But just to pronounce in five years, and then office supplies. This is just because we want to be able to provide things for the other members of the society like if they need notebooks and also we have a couple of printers in our office that we would like to use that we're still trying to figure out how to use but we think and such also to buy some decor for the office because it's kind of bland right now

- c. 21F- Pre-Dental Society
 - i. Motion to open appropriation 21F pre-dental society
 - ii. Alexandra Jaquez and Jared Romero: We are an organization that helps pre-dents get into dental school. So what we try to do is we encourage our students to learn more about it by event is by inviting schools but even traveling to dental schools. So that's what we're here to, to do today. So, on our operation, we asked for budget to go to the Michigan mercy. This is a organization where we volunteer and we provide assisting we learn about all these different procedures and they've even started 500 New Mexicans and what we're doing is we're learning about what it takes to be a dentist we talk to oral surgeons and we talk to all the specialties and so last

year's was in Farmington and this year is going to be in Santa Fe. So what we want you to do is just ask for some lodging but it's totally understandable. I know that we are tight on budget and this is going to be April. So that is totally understandable if we can't get that covered. But one of our things was our students said that they couldn't go to Farmington because there was no they couldn't stay anywhere. And so we want to open this opportunity to many people and some of that happens through funding. We don't want that just because they don't have money they don't get these opportunities. So one of the things that we did was we went to woodly hunt, School of Dental Medicine and we were able to go and shadow at the clinic we were able to meet the admissions team, we were able to meet the dental students and it was such an eye opening experience. And some some of these are pre dental students. And we actually got some of the students actually apply this year and they're actually getting interviews. And that's because we know the admissions team we met them and I mean I'm really close with said that's why the admissions teams so we really ask for some money about this and it's our closest school to in New Mexico and they actually have an agreement with New Mexico where they'll get in state tuition to New Mexico students as they come back. So this is also sponsoring that the idea that we need more help professionals and New Mexico so this is also helping our students realize we have support here. And so another thing is School of Dental Medicine. This is a Colorado. This is a school that we have not yet visited. And so what we've tried to do is broaden our scope, right? We want to make sure that our students are able to meet new areas and we want to make sure that our students are are seeing new campuses. And these are a few of our alumni from here at UNM and they got into Colorado this year.. So what we're trying to do is they invited us over to Colorado to go and visit their campus and they're making an organization, an event for the period of society. So we're wondering if we can also get help with that and young Casey School of Dentistry, correct. So this is a school you visited last year as well. And it was such an amazing opportunity. So what we did was we visited the school we were able to work with the Friends of students, we were able to work with their tools, and we actually met with the admissions team. I got interviewed at UMKC and it I felt

like the reason for that was because I was able to meet the admission staff. Also a few of our dental students went to the apply to the pre dental program that was offered during this opportunity called Star and for our pre dental students got in this is an exclusive event and it was such an opportunity and what the admissions team emailed the panelists today saying that we were presented to Mexico correctly and they're really proud and hopefully like us more and right now they have for Mexico dental alumni. And finally, that's just the really expensive so they were asking for so I want to just to make sure that I'm providing evidence

 - 2. Alexandra Jaquez and Jared Romero: Yes.
 - 3. Senator Tomaziefki: In the appropriation you requested funding for just the officers,b ut in the presentation you explain that other members of the community have the opportunity to go, can you explain a little more about how that funding is received?

We are just here to present to maybe basically get some funding for our activities for a club. We have currently about 55 to 60 active members that are currently participating in our activities. In addition, we do allow non members to participate in our activities. That is not a requirement of membership to participate. We do want to include everyone. So I'll go through our this semester this year, we're going through an entire rebrand of the premed society in the past years, it kind of was mostly focused towards pre medical students. So students looking to go into medical school. Last year we started make it more open to all pre health tracks, and we're continuing on this year. We're trying to be more open and inclusive of all pre health professions. So as part of our plan, we were bringing in a lot more PAs so physician's assistants, we're bringing in nurse practitioners, well on top of bringing in all the different doctors that specialize in different thingsSo as part of this plan, we also plan on bringing multiple. We're planning on holding multiple panels. Our first panel is going to be not next Wednesday, but the Wednesday after that. It's a graduate student panel. So we're even catering students who are looking to go into graduate school and to kind of segue off from that I'm part of part of this rebrand. We've

We've started pushing into multiple social medias that we previously didn't have. This includes Tik Tok and Facebook. And unfortunately, our social presence on these platforms has is super small. And as you guys may know, it's like starting off, it's very hard. So that that kind of that's the reason why we're requesting advertising money in order to try and build up those accounts. All of those accounts already have posts on them. And they've done okay, but I think with advertising, we can definitely push that to a to a higher amount and there's a huge pre health profession, population on campus, and we're trying to cater to all of them and make them aware of us. An example of this as we went to every single NSO this year, as well. As we'll come back days and we tabled for all those which led to our increase in members. But we're hopefully trying to increase that even more. And I think that the advertising portion would would definitely assist us with that. To move on. We asked for a food budget currently in our budget that we proposed last spring for this for this year. We only had one food of one food events, I guess one food item so it's for one event, and it's for our banquet. Sorry as far as end of year banquet, so that doesn't happen till the spring and it's for \$600. But we haven't been able to use any of that money on any of the events that we've had up so far. So that's why we're requesting this. So our meetings are kind of split into two different parts. We have general meetings in which the members kind of all convene, and we all it's usually either social, or more academic, but it's like peer to peer. And so during these meetings, we usually don't bring in any speakers. And then we have a different type of meeting event which is the meetings were in which we bring in speakers and during these meetings, we have a huge influx of members that actually members and non- members that attend these events, and we we haven't been able to supply any of them with food up to this point and has all of our events are held here in the south. And we have to go through the sub catering. That gets really pricey really fast since they charge purpose and right now we're averaging it fluctuates from 50 to 60. Members. I think our meeting two weeks ago, had close like 65 members we have places to sit and we couldn't provide anything and if we were to go through and a catering for that it'd be a huge bill and so that kind of explains the the reasoning behind the amount that we're requesting. Finally

our office supplies. Currently our office is downstairs in the mobile layer. And our office is open to members when there's an officer in the office because obviously we can't give everybody card access. And so right now we're running very, very low on office supplies and this is just like general stuff, pens, papers, staplers, journal general stuff that can be used in the day to day, the day to day running of the organization. And that is why we're requesting that funding for our office supplies just to kind of be able to stock up some of those things which we're running very low on in most of the time. There's none. No, no office supplies in the office. So yeah, I think that is the last one. Oh, surgery it's the most important part. So as part of our as part of our organization we did at the moment we started out at the moment but as previous years we usually hold a suture workshop, two in the spring and it's held once every year. And basically we bring in multiple medical students that already know how to suture and they teach undergraduate students how to suture. The suture kits usually are shared between two people. And so in the past, we've had to limit the amount of students we can take due to the limited quantity of suture kits, so I wasn't sure what they fell under, just because they're kind of like one time usable. And especially when we have multiple students using one suture kit. It's not really usable pass the first time and so that is for 10 units and the the suture kits run about \$100 each. I wasn't sure whether to include a guote or not because it wasn't a single item over four or 500 it was I can't I'm sorry, I know you guys are gonna cut cut, because that's fine. But yeah, basically, that's why we're trying to hold our suture workshops twice a year instead of once a year to allow more students to participate in it. And so our planned suture workshop for this year is going to be November 1 And then we'll probably build another one in the spring, though as suture kits that we don't use for use very lightly. We'll probably move on and use it in the second suture workshop that we hold, but at the moment we have none. And so we have to purchase those for that upcoming suture workshop. Yeah, I think now everything is covered.
